UNAUTHORIZED CONSTRUCTION CLOSE TO 16 FAD

1. It is intimated that depot perimeter have been checked on ground by security staff of this depot, it has been observed that Mr. Kharak Bahadur Sinha of village Tarabari has started construction within 500mtr range of the depot perimeter.
2. This depot is sensitive military installation holding hazardous ammunition. For the purpose of safety of public life & property, it is extremely important that settlements close to the installation is restricted beyond the mandated safety distance, in this case, 800mtr from the boundary of the depot.
3. It is therefore requested to sensitize the Police Station, Bagdogra and also the villages adjacent of this depot to adhere to safety regulations. The same is being carried out at unit end as well. It is requested to stop the construction at village Tarabari to avoid any untoward incident.
