Sir,

In producing here with the one accused person namely Karma Oraon (30) s/o Late Hindu Oraon of Champasari, Behind Gramin Bank, PO Champasari, PS Pradhan Nagar, Dist. Darjeeling following seized articles as per proper seizure list:

1] Twenty (20) Bottles of Himalayan Gold 60 UP Country Spirit each Bottle containing 600 ml

I, SI Srimanta Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused person to the effect that on 18.02.2022 at around 14.25 Hrs received a source information that the above noted accused person has possessed huge amount of Liquor for the purpose of selling the same to local customers at Gandhinagar More, Near Mahananda Bridge under Bhaktinagar PS. This refers to BKN PS GDE No. 892, Dt. 18.02.2022. Accordingly the information shared before you and as per your kind direction I along with ASI Dipak Karmakar, Constable C/762 Debraj Biswas, CVF-014 Labanyamoy Barman headed towards Gandhinagar to verify the veracity of the information. At about 14.35 Hrs we reached at Gandhinagar More near Mahananda Bridge and as shown by the source intercepted one person who disclosed his identity as noted above. Further maintaining his decency and observing all formalities searched him and recovered huge amount of above noted seized liquor from his possession. On demand he could not produce any valid documents in respect of the recovered liquor. On enquiry the apprehended person admitted his guilt and confessed that he has possessed above noted liquor for transporting the same at Gandhinagar Area to his designed customers. He also stated that he has been doing this illegally since long without any valid licence or Documents for his wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made between 14.45 hrs to 15.05 hrs. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your kind honour that a specific case may kindly be registered against the accused person namely Karma Oraon (30) s/o Late Hindu Oraon of Champasari, Behind Gramin Bank, PO Champasari, PS Pradhan Nagar, Dist. Darjeeling under proper section of law and arrange for its investigation.
