Sir,

In producing here with the one accused person namely Arun Kumar (27) s/o Prem Pukar Prasad of Prakashnagar, Near Traffic More, PS Bhaktinagar, Dist. Jalpaiguri along with following seized articles as per proper seizure list:

1] Fourteen (14) Bottles of Himalayan Gold 60 UP Country Spirit each Bottle containing 600 ml

I, PSI Sailesh Subba of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused person to the effect that on 18.02.2022 at around 15.05 Hrs received a source information that the above noted accused person has possessed huge amount of Liquor at his Tea Shop situated at Prakashnagar More under Bhaktinagar PS for the purpose of selling the same. This refers to BKN PS GDE No. 896, Dt. 18.02.2022. Accordingly the information shared before you and as per your kind direction I along with ASI Rabin Lama, Constable C/762 Mujibul Rahaman, CVF-614 Sumit Kumar Roy headed towards Prakashnagar More to verify the veracity of the information. At about 15.20 Hrs we reached at Prakashnagar More and after being identified by the source I along with my team held raid at the said Tea Shop and apprehended one person. On being asked the apprehended person disclosed his identity as noted above. Further maintaining his decency and observing all formalities searched his shop and recovered huge amount of above noted seized liquor. On demand he could not produce any valid documents in respect of recovered articles. On enquiry the apprehended person admitted his guilt and confessed that he has been storing the liquor for the purpose of selling to the local customer without any valid licence or Documents for his wrongful gain. Accordingly, I seized all the recovered liquor in presence of witnesses duly sign by them as well as accused person. The seizure was made in between 15.35 hrs to 15.55 hrs. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your kind honour that a specific case may kindly be registered against the accused person namely Arun Kumar (27) s/o Prem Pukar Prasad of Prakashnagar, Near Traffic More, PS Bhaktinagar, Dist. Jalpaiguri under proper section of law and arrange for its investigation.
