I, PSI Sailesh Subba of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused person to the effect that on 18.02.2022 at around 15.05 Hrs received a source information that the above noted accused person has possessed huge amount of Liquor at his Tea Shop situated at Prakashnagar More under Bhaktinagar PS for the purpose of selling the same. Accordingly, I seized all the recovered liquor in presence of witnesses duly sign by them as well as accused person. The seizure was made in between 15.35 hrs to 15.55 hrs. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.
