In producing herewith one accused person namely Bikash Roy (34), S/O- Late Sanu Roy of Bholanath Para PS Bhaktinagar Dist. Jalpaiguri and the following articles under seizure:

(1) 12 (Twelve ) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.120/- (Total- 7.2 Liter & Amount Rs 1440/-).

I SI Pradip Kr Singha of Ashighar OP lodged a written complaint against the accused person namely Bikash Roy (34), S/O- Late Sanu Roy of Bholanath Para PS Bhaktinagar Dist. Jalpaiguri to the effect that, on 18.02.2022 evening as per order of O/C Ashighar OP I along with ASI Krishna Ch Singha C/ 877 Munna Ahmed and CV/1016 Amrit Roy, all of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashigarh OP as per order vide Ashighar OP GDE no. 574 Dt 18.02.2022 in course of which I received information from my source that one Bikash Roy stored a huge numbers of bottles of liquor inside his house at Bholanath Para and used to sell to the local youth in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Bholanath Para to verify the veracity of information. On the way I called two local person namely (1) Dipankar Saha (33) S/O Shankar Saha of Niranjan Nagar W/no.36 PS Bhaktinager Dist. Jalpaiguri and (2) Ajay Sarkar (32) S/O Sunil Sarkar of Gliogomali PS Bhaktinager Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Bholanath Para area as indicated by my source I held raid at the house of Bikash Roy at Bholanath Para .But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his house . I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 19.35 hrs and 19.55 hrs on 18.02.2022.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons Bikash Roy (34), S/O- Late Sanu Roy of Bholanath Para PS Bhaktinagar Dist, Jalpaiguri and arrange for its investigation.
