SUB: CHEATING OF RS. 100,000/-DONE BY PRADEEP KUMAR SAW & DIPAK

Most respectfully, I, Parveen Agrawal, S/O. Late Mahavir Prasad Agrawal, authorized person of M/S Davesh Traders, a proprietorship firm, having its registered office at Udham Singh Sarani, Ashrampara, P/O & P/S. Siliguri, District Darjeeling-734001

That our firm deals with second hand/used parts of JCB and other machineries and I came to contact one Pradeep Kumar Saw (Cell No.8840171400) (hereinafter referred to as accused), resident of Dankuni under P/S. Dankuni, District Hoogly on 30-01-2022 and visited his office situated at Dankuni and our deal was finalized for Rs.250,000/-(Rupees two lac fifty thousand only) in respect of one second hand engine of VOLVO-480 of JCB. The said accused gave me his bank account No.48920100000545, having its IFSC code BARBOMANIKT of Bank of Baroda for transferring of Rs. 100,000/- as an advance which was agreed upon between us. But subsequently the accused cleverly posted me on my what's app number (7580891421) another bank account number of Dipak Kumar Sahoo (Cell No.7008107553) being No.50100399874742, having its IFSC code No.HDFC0009192 of HDFC Bank for transferring the advance of Rs. 100,000/ as settled between the parties.

That thereafter Shri Ashok Kumar Nad, proprietor of M/S. Devesh Traders transferred Rs 100,000/- on 01-02-2022 to the above mentioned bank account of Dipak Kumar Sahoo through NEFT. The Xerox copy of the NEFT document issued by State Bank of India, Haldepara Branch, Siliguri is being annexed hereto for your kind perusal and marked as "Annexure-A" to this complaint. It is quite apparent from the unlawful act of both the accused and there accomplice viz. Pradeep Kumar Saw & Dipak kumar Sahoo that I have been cheated by them by their connivance in the matter.

That on 29-01-2022 I myself travelled by Padatik Express from NJP to SEALDAH and returned back on 02-02-2022 by the same train. The Xerox copies of the said train tickets are annexed hereto and marked as "Annexure-B & C". That after transfer of said amount of Rs.100,000/- (14-02-2022) this complainant again went to the office of the accused on 15-02-2022 (by train-Shatabdi Express) for collecting the said engine of the JCB after making balance payment of Rs.150,000/- but the accused refused to deliver the engine and even used filthy language and threatened me of dire consequences if I don't leave the place. That on 17-02-2022 I had to return (by train-Shatabdi Express) empty handed, neither the accused delivered the said engine nor he refunded the advance money of Rs. 100,000/-. The Xerox copies of my two train tickets and two hotel bills are enclosed herewith and marked as "Annexure-D,E,F & G". In my foregoing paragraphs there are sufficient documentary evidences in support of my claim & said deal and payment of Rs 100,000/- and it proves that the intention of the both accused was malafide from the beginning and ultimately they succeeded in cheating my company for Rs. 100,000/-.

Under the above facts and circumstances, you are, therefore, requested to take cognizance on this complaint and book the culprit/s under the provisions of law for the ends of justice & oblige.

This complaint may kindly be treated as an F.I.R.
