Since the date of my marriage, my husband at the instigation of his family members started to create pressure upon me to bring a sum of Rs. 5,00,000/- from my parents and when I refused to bring the same, my husband and his family members in conspiracy with each other have started to create tremendous mental and physical torture upon me but I bear all such 23/02/22 al. 22.45h type of inhuman torture of my husband and in laws members with a hope that in near future they will realize their mistake and rectify themselves but all my hopes have gone in vain and ultimately, after elapse of 10 years of our marriage, I was driven out from my matrimonial house on 12.11.2019 due to non-fulfillment of their demand of more dowry and finding no other alternative, I was compelled to take shelter at my parental house and during my stay at my parental house after being driven out from my matrimonial house, my parents alognwith our well wishers have visited to the house of my husband to settle the disputes considering our future conjugal life as well as the future career of our two minor daughters and every time, my husband and his family members abused my parents and relatives with filthy and abusive languages and also threatened us with dire consequences by saying that until and unless my parents will not fulfill their further demands, they will not accept me in their house. In the mean time, myself along with my family members have made several attempts and request my husband and in laws members to restore our conjugal life as still now I am ready and willing to lead a conjugal life with my husband on and from my matrimonial house for the sake of future career of my our two minor daughter but every time, due to their adamant and reluctant attitude and behavior, our martial life could not be restored till now.
