Sub: Written Complaint

Respected, Sir/Madam

I Smt. Riya Sarkar (Poddar) W/O Babai Sarkar C/O Chitto Ghosh, Tumal para, W/No. 04, P.O.&P.S. Siliguri Pin- 734001. I would like to inform you that I married to above noted person (Babai Sarkar) on 07-12-2014 according to Hindu Marriage with the customary rites and ceremonies in term of Section 5, 7 of the Hindu Marriage Act and according to our consent/desire have done marriage registered under Hindu Marriage Act, 1955 on 2<sup>nd</sup> day of April 2015 been registered.

After 1 years of the marriage my husband demanded cash amount of rupees 2,00,000/- from me and my parents but my family is not financially sound so due to not fulfillment of such demand he used to scold me and threatened me tortured me physically and mentally and keep saying that I want money and I don't know from where you will bring, if you will not able to bring such amount than don't stay with me and further he will not able to provide any food and shelter to me So, go back to your mother house I won't accept you as my wife. And as per my mother-in-law namely Smt. Seema Sarkar, father-in-law namely Sri. Sunimol Sarkar and sister-in-law namely Smt. Megha Sarkar @Khan and they all join their hands of his brother/son and started demanding and tortured me physically and mentally and every day they were keep saying that if you will not bring money than I won't let you to stay in my house and we will not let you to live your happy married life with my son and if you not able to fulfilled our such above noted demands than we will not accept you as my daughter-in-law and also we will think that their was no marriage between you and my son and also we will remarriage of my brother/Son and as soon as possible otherwise fulfilled above noted demand or leave the house and don't return back and if you will try to lodge any complain against me and my family members than your life will be at risk, with that fear I came back to my mother's house because I was having child in my womb of a month and for saving me and my child life.

That During the time of pregnancy I was resided at mother's house and on 30-05-2016 I delivered a baby boy namely (Sayan Sarkar). At such crucial time my husband and no one of his family members come forward to see me and my child. After a long gap my husband get agree to continue our relationship that on 5-07-2017 With the help of senior citizen of our locality tried to settle down of our matrimonial dispute, at that time in the presented of such senior citizen and present of both the family members and my husband has give me in the written form that he want to continue this married life with me and my child and he will look and take care of me and our child and he promise me that he will changed his behavior towards me.

That after coming back to my husband house few months later he used to come back home fully drunk condition and again he started demanding and physically and mentally tortured me continuously and during that time my baby child started hue and cry and could not able have a good

sleep after that I communicate with my husband's family members on such daily issues but no mercy has shown towards me and my baby child thereafter, they were supporting to my husband and they again joined their hands and they jointly started making such unnecessary demands and they used to Physically and mentally tortured me and they also used to physically assaulted and every day they used to filthy languages towards me and my family members due to all of this I was started falling sick and their was no one to taking care of me and my child and I felt risk so, I decided to communicated with my Parents and to go back to my mother house.

That after coming to my mother house they never tired to contact me and from other source I came to know that he is in relationship with some one namely (Pinky Prasad) by knowing such information I tried contact my husband over phone but he don't answer any of my calls and I also tried several time to contact his family members too but I failed to communicate but One day I got a phone call of my husband he start demanding above noted demands after few months he send me a Notice through by post for restart conjugal relationship thereafter when I received said notice at that time their was a lockdown due to Covid-19 at that time I was resided at my permanent resident at Gosaihat Bandar, Bajit Chatra, Baradhaperchata, Cooch Behar Pin- 736172. During that time my family financial condition goes down, and me along with my family members was facing hard time thereafter, I received second notice my sister-in-law i.e. my brother wife and my brother decided to go to my husband house after the situation came into control of Covid-19. My brother and wife of my brother went to my husband house to settled down such issues but they started shouting and using filthy languages towards them and they returned back home and they said that such said notice was send for formality and its means that now there is no marriage sustained between your sister and my son and my son is going to started his new life as soon he is going to get married.

After few month of said incident I came to know that my husband above noted women got married namely (Pinky Prasad) and with whom he was in relationship before second married now they together residing at in the locality of Vivekananda Nagar (Koyla Deepu) at Siliguri by listening such information I broken down.

Therefore, I couldn't found any way with the help of my well wishers I am lodging this F.I.R and praying before you for a new hope in my live and to provide justice to me and my son now he is about to attain 6 year and I am totally helpless and I am seeking your help and registered my F.I.R on subject matter and take necessary action as soon as possible against above noted persons for the ends of justices.
