I, Smt.Swapna Sen @ Swapna Chaki, W/O Sri Uttam Chaki, D/O Sri Pradip Sen, now resident of C/o Sri Pradip Sen, Ambika nagar, P.S. N.J.P., Dist. Jalpaiguri, do hereby S/O Lt. Subhas Chaki, permanent resident of Surya Sen Colony, E Block , P.S. N.J.P., Dist. Jalpaiguri who works in Private Company for a salary of Rs 20,000/-(Rupees my father's house in Ambika nagar. My father and other family members tried to meet the dowry demands of my husband and in laws in form of cash of Rs. 50,000/- (Fifty Thousand only) , Gold ornaments worth Rs. 3,00,000/-(Three lakhs only) ,steel furniture, clothes and utensils and after marriage, I started living with my in laws, in my matrimonial house at Surya Sen Colony, E Block , P.S. N.J.P., Dist. Jalpaiguri .

Since the day of my marriage, my husband, Uttam Chaki, mother in law Chhabi Chaki, brother in law Utpal Chaki and his wife Sarmila Chaki kept on demanding dowry of Rs 1,00,000/- (Rupees One Lakh only) and when they realized that my family could not provide the dowry demanded by them, they started misbehaving with me .They used abusive language towards me and even called me a Bastard and made me do all household work without giving me time to even eat or sleep, which was making me sick very often .They almost treated me like a slave and neither provided sufficient food nor clothes or even the bare necessities and they were always criticizing whatever I did. They did not allow me to use light and fan for myself and if I dared to protest they used abusive language and threw me out of the house on several occasions.

Even my husband disliked me from the very date of marriage and told me that he did not want any relationship with me and that he agreed to this marriage only for dowry. He hated me for spoiling his life and used to often quarrel with me and beat me with fist and blows for not providing the cash amount of Rs.1,00,000/- as per his and his family's demand. From one night in the month of April 2021, I.e just one month after marriage, my husband quarelled with me on flimsy grounds and bea me and left our room and from that day he slept with his mother at night for reasons best known to him. My husband never tried to protect me from the harsl words and rude behaviour of my other inlaws and instigated them against me and even beat me with fist and blows. My brother in law, who even threatened to kill me and his wife used to often use bad language against me in front of others and ofte they threatened me that they will kick me out of their house and give my husband marriage to a another girl with more dowry. Thus my husband, Uttam Chaki, mothe in law Chhabi Chaki, brother in law Utpal Chaki and his wife Sarmila Chal subjected me to torture and ill-treatment continuously and I tried to adjust wit their behaviour day after day thinking that they will change.

But my inlaws made my married life in my matrimonial house more and more intolerable every day .On 15/01/2022 at night, my husband started quarreling with me over some flimsy issue and my mother in law came and spoke in very abusive and provocative language and my husband's elder brother kicked me in my back . My mother in law then told me that some ojha had told her that if five persons stay My mother in law then told me that some ojha had told her that if five persons stay in their house ,one will die , so I have to leave their house and there after my husband Uttam Chaki, mother in law Chhabi Chaki, brother in law Utpal Chaki and his wife Sarmila Chaki beat me and drove me out of their house without food or money and some how with the help of some kind people I managed to come to my father's house at Ambika nagar . All my stridhan and personal things were kept by them.

My family tried to reconcile the matter in several ways and even called my husband and his family members several times in order to reconcile the matter but my husband and other in laws were rude to my family members and demanded the dowry amount of Rs.1,00,000/- from them. When my family told them that they cannot give the money, they misbehaved with my family and my husband told me that I had spoiled his life and that he cannot stay with me for the rest of his life and trenounced the marriage and my brother in law repeatedly told me I would face dire consequences if I even tried to return to their house without the dowry .

My family has tried to mediate so that I could go back to my matrimonial house but did not succeed. As such no further mediation is possible under the circumstances. My husband and my said in-laws have kept my stridhan with them and I fear that they may misappropriate the same. During this short span of my married life, I have suffered a lot because of the continuous physical and mental torture by my husband and my said inlaws.

Sir, the aforesaid activities of my husband, his mother, his brother and wife of his brother have gone beyond my tolerance. I have lost all my hopes to resume my matrimonial life any further and I am certain that I will be killed if I return to my matrimonial home. I am now in a helpless condition and I need your help urgently to matrimoniate legal action against my husband, Uttam Chaki, mother in law start appropriate legal action against my husband, Uttam Chaki, all residents of Chhabi Chaki, brother in law Utpal Chaki and his wife Sarmila Chaki, all residents of Surya Sen Colony, E Block , P.S. N.J.P., Dist. Jalpaiguri.

It may be mentioned here that I could not lodge the FIR earlier because I was in a state of shock.
