In producing herewith arrested accused person named Rishikesh Sharma (54), S/O - Late Bishnu Bhakta Sharma, of - Kawakhari, Medical More, PS - Matigara, Dist - Darjeeling along with copy of memo of arrest and seized articles (i) 30 (Thirty) Sealed Himalayan Fata Fati Bottles 70 Up Country Spirit each containing 300 MI Rs. 28/- each totaling amount of Rs. 840/- with proper police escort.

Today i.e on 27.02.2022 at 18.05 hrs, ASI Pradip Singha of NBMC OP along with VP 06 Nitish Singha and CV 158 Partha Sarkar of NBMC OP under Matigara PS, while conducting special raid against anti social elements, warrantees, ID liquor etc in vehicle no WB74/8035 at different area under NBMC OP in course of which I received an information from source that a person is selling and stored illicit Liquor in huge quantity in a clandestine way in patty shop at Kawakhari under Matigara PS. During raid I found one Rishikesh Sharma (54), S/O - Late Bishnu Bhakta Sharma, of - Kawakhari, Medical More, PS - Matigara, Dist - Darjeeling is possessing 30 (Thirty) Sealed Himalayan Fata Fati Bottles 70 Up Country Spirit each containing 300 Ml Rs. 28/- each totaling amount of Rs. 840/- hidden inside his shop and selling it to the customers in concealed manner. Accordingly I seized the above noted articles in presence of police witnesses, I demanded papers and license / cash memo of those seized articles but he failed to produce any documents in support of his possession of above noted illicit liquor. On interrogation, he disclosed his name as mentioned above and admitted that he procured the liquor illegally and had been selling the same illegally to the people. I accordingly, seized those illicit liquors U/S - 102 Cr.P.C in presence of witnesses after preparing proper seizure list duly singed by the witnesses as well as the accused and also labeled the same. Then, I arrested him u/s - 41 Cr.P.C with help of Police personnel. The search seizure, label and arrest were made from 19.20 to 19.40 hrs. Then we left the place with the arrested person and the seized articles.

Under the above circumstances I pray before your kind self that a specific case under proper section of law may kindly be initiated against the accused person named Rishikesh Sharma (54), S/O -Late Bishnu Bhakta Sharma, of - Kawakhari, Medical More, PS - Matigara, Dist - Darjeeling and kindly arranged for its investigation.
