I, ASI Rabin Lama of Bhaktinagar PS, SPC do hereby lodge a complaint against the above noted accused Biplab Sarkar @ Kangaroo S/o Lt Bipat Bhajan Sarkar of Janata Nagar, PS Bhaktinagar, Dist: Jalpaiguri to the effect that on 01.03.2022 one known person but who did not want to disclose his identity informed us that one Biplab Sarkar @ Kangaroo of Janata Nagar, under Bhaktinagar PS, Dist: Jalpaiguri is roaming at around the locality and he is showing small arms with a view to commit crime in Bhaktinagar area and accordingly engaged sources to verify the veracity of the information.
