- 1. That Sumit Kumar Sinha, Son of Sachinanda Sinha, resident of Kumar Bag Road, Near Hanuman Mandir, Arsandey, P.O + P.S. Kanke, Dist-Ranchi, State of Jharkhand Pin-834006, is my legally married husband and our marriage was solemnized on 11.12.2020, after following all the rituals and ceremonies of Hindu Marriage Act, and at the time of my marriage my father gave Cash rupees one lakh and gold ornaments worth rupees ten lakhs and other valuable house hold articles worth rupees five lakhs as per their demand and promised to give brand new Swift Car after my marriage to my in laws as open their demand after selling his land as no appropriate purchaser was available to buy the same.
- 2. That after the marriage my husband took me to his house at above mentioned address, where we lived together as husband and wife.
- 3. That after 10-15 days of my marriage my husband, (i) Sumit Kumar Sinha, mother in-law namely (ii) Susma Sinha, sister in-law (iii) Sweta Sinha, (iv) Salini @ Pooja Sinha started to torture me both mentally and physically on the ground of not giving them a new brand car as demanded by them at the time of marriage which my father promised them to give them but just after few days of marriage they started to pressurized me to bring the new car from my father's house and their relatives namely (v) Geeta Singh, wife of Chandan Singh and younger sister of sima devi, (vi) Chandan Singh, son of not known, (vii) sima devi mother of Rajen Prasad, (viii) Rajen prasad Son of late kalicharan Prasad, (ix) Shima Devi, wife of Late Kalicharan

- 7. That since thereafter, my father tried hard to sell the land but due to pandemic no one was willing to purchase the land and since then I have been residing at my father's house.
- 8. Today that my husband came at my father's house and asked my father to clarify the matter whether he would give brand new car or else he would send divorce papers then I and my father and other family members made them understand but he did not listen to anyone and went away from there and told that he would marry again with another lady if my father do not fulfill his demand within a month and we could not do anything of him as our marriage is not a Registry marriage.

I, therefore, request to you to kindly take necessary legal action in the aforesaid matter against the aforesaid persons for the commission of aforesaid offenses.
