Producing herewith three accused persons namely 1) Md. Sahabuddin (M/44) S/O. Lt. Md. Rahim of Polsha, Dalkhola, PS. Karandighi, Dist. Uttar Dinajpur, 2) Babul Hussain (M/34) S/O. Rafikul Islam of Kolaiboktari C/O. Md. Kalua PS. Matigara, Dist. Darjeeling, 3) Hari Das (M/28) S/O. Sambhu Das of Barivasa near Bhabesh More PS. NJP Dist. Jalpaiguri along with the following articles Viz:

Two Fifteen Foot iron made railway Track.

2) One Iron made drain Cover measuring 03 feet / 02 feet.

3) One Iron made drain Cover measuring 03 feet / 03 feet.

4) One Iron made drain Cover measuring 2.5 feet / 02 feet.

5) One Tricycle Van which was loaded with Two Fifteen Foot iron made railway Track.

One Tricycle Rikshaw which is loaded with three drain covers.

In this regard I ASI Uttam Kumar Dhar of Khalpara TOP. PS. SLG SPC beg to state that on dt. 01/03/22 at 02.30 hrs during my K27 Night Van duty Vide Khalpara TOP GDE No. 665 Dt. 28/02/22 with C/.390 Sujit Paul and CV/05. Gobinda Das at Jhankar More area found five person along with one Tricycle Van and one Tricycle Rikshaw coming from Thokkor Bridge Side towards Jhankar More loaded with some heavy and long article. Seeing the persons we get down from the vehicle and started towards the Van and rikshaw. Seeing the Police personnel the five persons started fleeing away and we somehow managed to apprehended three of the persons and on being asked they stated their name as noted above. Thereafter we along with the three apprehended persons went to the Tricycle Van and Tricycle Rikshaw and found the Two Fifteen Foot iron made railway Track loaded in the Tricycle Van and three drain covers are loaded on the Tricycle Rikshaw. I asked them why they were here at this dark hour but they were unable to state any satisfactory answer regarding their presence at the spot, I also asked them to produce supporting documents in respect of the iron made articles but they fail to produce any supporting documents in-respect of the articles. Finding no other option they stated that they three and two other procured the said iron made articles from illegal means for their wrongful gain and both the cart poolers escaped from the place. Accordingly I seized the above noted articles at 03.15 hrs in presence of Police witnesses as in such late hours no public witness could not be contacted and then arrested the accused persons from 03.35 hrs to 03.45 hrs.

Therefore I pray before your kind self that kindly take charge of the seized articles and a specific case may kindly be started against the three accused persons 1) Md. Sahabuddin (M/44) S/O. Lt. Md.
