I, ASI Gazi Rahaman of Panitanki TOP under Siliguri PS do herby lodge a written complaint against the above noted accused person to the effect that today on 05/03/2022 at 19:05 hrs during mobile van Juty I received secret source information that, one person is selling huge quantity of country spirit at Sevoke Road Near Guruduwara, under Panitanki TOP. Accordingly I informed the information to OC Panitanki TOP and as per his direction I along with ASI Gazi Rahaman, C/114 Naresh Hausda, and CV-1009 Monoj Thakur left for PO to work out the information. On arrival at Sevoke Road near Guruduwara at 19:15 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. I intercepted the said accused person with loaded articles in presence of witnesses. During interrogation the accused failed to produce any documents/license in support of the same and stated that he will sale the same to the local public of Mahakalpally adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I intercepted the said person with loaded articles in presence of witnesses. On search I recovered (i) 10 (Ten) Bottles of 60 UP Country Spirit styled as HIMALAYAN GOLD measuring 600 ml each when packed, MRP Rs. 120/- each (ii) 01 (One) Nylon Bag which used for carrying the seized articles SL No- 01.

On interrogation he failed to produce any valid documents/license in support of the same and stated that he sailed the same to the local people illegally with a view to earn huge money for his lively hood. Accordingly I seized (i) 10 (Ten) Bottles of 60 UP Country Spirit styled as HIMALAYAN GOLD measuring 600 ml each when packed, MRP Rs. 120/- each (ii) 01 (One) Nylon Bag which used for carrying the seized articles SL No- 01 under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person and arrested him.
