I, PSI Newton Biswas of Matigara Police Station here by lodge a written complainant against the above noted accused persons to the effect that today on 13.03.2022 at 21.50 hrs. onwards while myself along with other officers and force performing lock down duty around City Centre area under Matigara PS found the above noted accused persons were loitering around City Centre area without wearing mask and also not maintaining social distance violating Govt. Order vide order No.753/XVII-ISS/2M-22/2020, dated-02.01.2022. Accordingly, I warned them to obey the Govt. order regarding COVID-19 but they did not pay heed to my words and strongly opposed my lawful direction. Accordingly, I arrested all of them namely i) Laxman Mallick, ii) Shiba Routh, (iii) Prem Routh, iv) Md. Samim, (v) Md. Irfan, U/S-41 Cr.PC. after observing all formalities

Therefore, I pray before your kind honour that a specific case may kindly started against the accused persons (i) Laxman Mallick (52), S/O Lt. Shambhu nath Mallick of Darjeeling More, PS- PDN, Dist- DJG, (ii) Shiba Routh (19), S/O Bhikari Routh of Chandmoni mela Ground, PS- MTG, Dist- DJG, (iii) Prem Routh (18), S/O Ram Kumar Routh of Siliguri Ward No-1, PS- PDN, Dist- DJG, (iv) Md. Samim (19), S/O Md. Nasim of Natun Para, Ramghat, PS- SLG, Dist- DJG, (v) Md. Irfan (19), S/O Md. Mansur of Biswas Colony, PS-MTG, Dist- DJG. under proper section of law and arrange for its investigation.
