Respected Sir,

I, Smt. Mira Gupta, wife of Sri Lalan Gupta, resident of Gadadharpally, main Road North, Post Office and Police Station Bagdogra, District Darjeeling, Pin-734014, West Bengal, India, would like to state that on 14.03.2022 at about 9.00 P.M. after having my dinner when I was walking infront of my house suddenly I saw one person of our locality namely Sanjiv Minj, S/o. Tarak Minj, R/o. Gadadharpally, P.O. & P.S. Bagdogra, District Darjeeling, Pin -734014, West Bengal, India, was urinating in front of the gate of my property. When I protested he started mis-behaivouing with me by using slang language at me. He was shouting and saying "Me adivashi hu aur me adibashi bikash parishad ko bulaunga aur tereko aur tere beta ko aandar karwaunga. Dekh tera kya halat karta hu". He pushed me due to which I fell down and got injury in my legs. I requested them not to assault me as I am an aged lady aged about 60 years but he didn't listen to me and physically assaulted me. I was totally shocked. I have been humiliated by Sanjiv Minj. On my hue and cry my son namely Manish Gupta came out of my house and saved me from his cruel hands and we went inside our house. He also threatened me & my son that as he is Schedule Tribe so he has the power to lodge false complaint and put us behind bars under Schedule Tribe Act. He was shouting in very abusive and slang language which a well-behaved person cannot utter.

I was late to lodge the FIR as I was not well & suffering from leg pain due to his physical assault. I am being mentally & physically harass by Sanjiv Minj unnecessarily without any cause. I have been physically assaulted and on the other hand I & my son are being threatened and harassed by Sanjiv Minj only as because he belongs to Schedule Tribe community.

It is requested before you in folded hand to kindly take strict necessary action against Sanjiv Minj, so that this type of incident never takes place again.
