

Sub: F.I.R. against Smt. Rubi Ghosh (Das), Dream Tower, First Floor, Raja Ram Mohan Roy Road by Lane, E.V. Pally, Siliguri, Dist- Jalpaiguri for making unauthorised & illegal reconnection of the disconnected service line and metering installation as per The Electricity Act 2003.

I, Sri Manoj Paul, Assistant Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do hereby lodge complaint against Rubi Ghosh (Das), Dream Tower, First Floor, Raja Ram Mohan Roy Road by Lane, E.V. Pally, Siliguri, Dist-Jalpaiguri for having committed offence as stated here under.

On 16.03.2022 at about 06:30 p.m. acting on a source information, along with 1) Sri Amber Ghosh, Sr. OE, Hakimpara CCC and (2) Sri Sudipta Moitra, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the flat of Rubi Ghosh (Das), Dream Tower, First Floor, Raja Ram Mohan Roy Road by Lane, E.V. Pally, Siliguri, Dist- Jalpaiguri and inspected service installation, metering installation of Consumer ID 412225155 in the name of Rubi Ghosh (Das). During inspection it was found that electricity was being used unauthorisedly & illegally by Rubi Ghosh (Das) by reconnecting the disconnected service line of the metering installation that was disconnected previously on 25.01.2020 due to non-payment of outstanding energy bill.

As unauthorised reconnection of the disconnected service line and metering installation was detected and the Energy Meter Make-Himachal Energy Pvt. Ltd., Serial No.- H246469 installed against Con Id. 412225155 seized (in Burnt Condition) by preparing a formal seizure list duly signed by representative of Rubi Ghosh (Das) and witnesses. The copy of the seizure list handed over to representative of Rubi Ghosh (Das) and his signature obtained as token of receipt.

As Rubi Ghosh (Das) has committed offence u/s 135(1)(a) & 138(1)(b) of Electricity Act 2003 by using electricity illegally & unauthorisedly by reconnecting the disconnected service line, you are requested to take cognizance of the same by treating this complaint as F.I.R. The seized articles are packed and labelled by me. Enclosure:
