This person has taken the full payment of Rs. 49,50,000 (Rupees Forty Nine Lakh Fifty Thousand) in three installments on 7th March, 2020 (Rs. 22,50,000), 19th November 2020 (Rs. 20,00,000) and on 5th June, 2021 (7,00,000) against GST invoice of Rs. 9,04,200.00 is attached along with the payments made.

Neither has he completed the work (not even a 50%) since 2 years nor are we able to contact him; he has not submitted the GST returns as well.

I believe he has committed a GST fraud of Rs. 9,04,200 against the total payment mentioned above. Kindly help us in recovering the tax amount and the principle amount and take necessary punitive actions against this defaulter whose PAN card number is CCDPS0149F and his phone number is +918250316913.
