Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 714 dated 16.03.22 and informed the fact to you. As per your kind direction and instruction myself along with ASI Khagen Barman, C/1053 Paresh Rava, HG/794 Ranjit Roy, VP/08 Laxman Roy, VP/13 Jamirul Islam, CV/306 Biswajit Roy and others all of NJP PS, SPC left for Jamai Hotel, NJP to work out the information in hand. At about 16.45 hrs we arrived at Jamai Hotel, NJP and being identified by the source, I held rald at the said hotel and managed to apprehended the owner of the said hotel.
