Bhim Kr Chhetri of Cyber Crime PS, Siliguri Police Commissionerate do hereby lodged a complaint that today i.e. 19.03.2022 at about 12.35 hrs while I am engaged on social monitoring duty at Cyber Crime PS, I found one facebook profile of Roneer Ghosh having URL https://www.facebook.com/tufanrock posted comments in the "Siliguri Times" online news portal uploaded coverage interview of the Commissioner of Police, Siliguri Police Commissionerate of dated 17.03.2022 regarding restriction of ricksaw puller in and around the main road of siliguri market area. That the said facebook user posted comments "If there is a Union for cycle rikshaw pullers and they plan to initiate legal action against this dalal, I shall be glad to cover up the costs for the legal fight for poor people as per my ability. Even the CM of Bengal supporters cycle rickshaw pullers and their progress, this outsider hindi speaking dalal must not be allowed to destroy Siliguri..."

All mentioned posts is likely to cause induce to commit an offence against any other class or community or can break the public tranquillity. His all posts with deliberate and malicious intention of outraging the religious feelings of a particular class of citizens. Thereafter the said post has received lot of comments and has been shared by other facebook users. In making his comments the accused person made provocations with intend to cause riot, intentional insult intend to provoke breach of peace by making statements which would create and promote enmity, hatred or ill-will between different racial, language or regional groups or castes or communities.

Therefore, I am submitting this complaint and requested to you that a specific case has been initiate under proper section of law and arrange for its investigation.
