Pvt Ltd & CEO of GoWaterless for Cheating & breach of trust

Sir.

I Mrs. Lalitha Nayak, W/o Shri Vir Vikram Rai, and resident of Pradhan Nagar Siliguri do hereby lodge a complaint against Mr. Nitin Sharma, One of the Director of Rewowlution Ventures Pvt Ltd & CEO of GoWaterless for Cheating, misguiding & breach of trust. Details of which furnished below.

That Online business webinar was hosted by franchise india on 05/06/2021.Go
Waterless was one of the participants. That on 06/06/2021 I got message from
Mr.Nitin Sharma(founder & CEO of Go waterless under Rewowlution ventures pvt
Itd.) about his initiative and Go Waterless(Msg copy attached). As the company was
working for a cause in saving water I decided to start Go waterless businessin
Bangalore. He requested me to transfer Rs.472000/- (Four lakhs seventy two
thousand only) to supply materials & equipments for GoWaterless business. I insisted
for Agreement Copy along with terms & conditions but he told to transfer amount first
and rest will be taken care later. Accordingly I transferred Rs.472000/- on 07/07/2021
from my Indusind bank Account (Account No 158167554343) vide Neft no
INDBN07073566072 to his company account Rewowlution ventures pvt Itd., held
with IDFC bank bearing account no 10048979416. As covid cases were increasing &
there was predictability of 3rd wave I requested for change of place to Siliguri from
Bangalore.

He then insisted me to open Car detailing studio instead of GoWaterless business. He also told me that Rs 472000/- which was transferred to his account will be used to purchase tools, equipments & detailing products for the car detailing studio. He then told me to select a suitable place for car detailing studio. He lied to me that he has four studios in pune one in bangalore and many more in pipeline(which was told in press meet on inauguration day also). He misguided saying that this business gives ROI in 8 months and is very lucrative. His intention was to make me open studio under his brand so that he could cheat others in the name of franchisee showing my studio, which he was doing immediately after inauguration. In the meantime he asked to contact Mr. Pratik Mukherjee (franchisee of Go waterless Siliguri)who will help us in setting up studio on

his behalf.Mr Pratik Mukherjee stands witness in this case(Mob No 9800011107).

On 9th SeptemberMr. Nitin Sharma called me saying he is in Delhi and was purchasing machines & materials for studio. He asked me to transfer 6 lakhs immediately for purchasing machines & materials. I immediately transferred 4lakhs to his company account Rewowlution ventures Pvt Ltd held with IDFC bank bearing account no 10048979416 vide ref no INDBN09091651085 from my Indusind bank Account (Account No 158167554343).

He had made below promises,

- 1)To provide all high end imported equipments & materials from Delhi.He even told he talks to each company head analyses the products and makes purchases.
- 2)Provide man power for the studio. Training of 1 month to be provided to each staff
- 3)All premium services will be available on the day of inauguration.
- 4)Inaugration expenses will be borne by the company
- 5)Company will Bear all marketing expenses
- 6)He & his team will monitor interior work of studio.

Trusting his words we agreed to invest in detailing studio. Everything was done as per his requirement.

Detailing studio located in eastern bypass,near baneshwar more.Inaugration was on October 2nd.He made us bear all inauguration expenses of around 60,000/-.No man power provided.No services were available.To our shock he had purchased cheap Chinese materials and equipments two machines were purchased in Siliguri itself.

When we started asking for machines & services he started getting irritated. We incurred huge business loss coz of this as we were not able to provide services to customers.

On asking several times to provide machines or return money so that we could purchase, but he neither returned money or provided bills of purchased items. Then he told he will be withdrawing his brand name but he didn't return money. As discussed with him We have returned few equipments back to him as they were of sub standard quality & few stopped working. On 16/11/2021 he sent whatsapp message saying he will repay in 2-3 days. As per our assessment he has supplied equipments & materials of approximate 1-1.15 lakhs. He paid back 1.5 lakhs on 27/11/2021. Inspite of several reminders on whatsapp he neither provided us the bill nor returned the remaining amount (approximate 6 lakhs). He has misguided us, cheated us used our money for his needs.

1)He has no Go detailing studios anywhere in india. He seems to be habitual cheater who cheats innocent people. Go Detailing brand didn't exist at all. He misguided and made us invest in this Go Detailing.

2)He had told us he is from Raipur.But his facebook shows from Bangalore.He keeps changing his address on social media pages.For returning of materials he had given Mr.Srikanth iyengar's pune address.He never shares his address.Genuine company will have a registered office.

2)He sells liquid in the name of eco friendly liquid under Go waterless brand which has no label,no ingredients written,no eco mark.

3)He is running ads for franchise for both Go detailing & Go waterless for Siliguri. His intention is not clear.

In these circumstances I request you to lodge an F.I.R. against Mr.Nitin Sharma & Other directors of Rewowlution ventures for Cheating, Breach of trust, deceit, Compelling to invest in his company by fake promises & malafide intentions causing harassment.
