I, SRI SANDIP KUMAR BANSAL S/o Sri Kanwar Sain Bansal @ Kanwarsain Agarwata arged resident of Seth Srilal Market, Sevoke Road, Siliguri, P.O. & P.S. Siliguri in the district Station Bhak the district of Bhak the district of Station Police Darjeeling-734001, would like to lodge a complaint stating as follows:

Siliguri Metropolitan Police

- 1. That my companies IDEAL DISTRIBUTORS PRIVATE LIMITED and SEABIRD NIRMAN PRIVATE LIMITED is the owner of land measuring 31.5 Decimal, appertaining to and forming part of R.S. Plot No. 455 corresponding to L.R. Plot No. 28 of L.R. Sheet No. 37 recorded in Khatian No. 150 of Mouza Dabgram, under P.S. Bhaktinagar in the District of Jalpaiguri by virtue of three deeds of conveyance being Document No. 1158, 1159 and 1160, all for the year 2010.
- 2. That in the meantime, we mutated our name with the Record-of-Rights and the concerned departments have also issued separate L.R. Khatians, vide L.R. Khatian Nos. 173 and 172 respectively and since then we are looking after the entire land.
- 3. That since few weeks some miscreants namely headed by Sri Kamal Kant Bhagat are trying to enter into the land and take illegal possession of the same but due to resistance from the employee of the company they failed to do so.
- 4. That today, i.e on 23.03.2022 at around 10a.m. it came to my the knowledge that the aforesaid persons along with few other anti-social element who are also the local land grabber have collected sand, bricks, cement and other materials infront of the road on the land with an intention to trespass into the land and make illegal construction over the land.
- 5. That on getting the information of the same, I along with the other employees of the company reached the spot. On seeing us approach the land, one of the person caught

That on hearing this, I immediately contacted the local police station and the officer incharge reached the spot and with the help of the police personnel, we somehow managed to restrain the said miscreants but while leaving they threatened me stating that they do not hesitate to shed blood and will take the possession of land at all costs and that

nobody can stop them from doing so.

8. That we are in a dilemma that if nothing is done the miscreants might at any time take

possession of the land.

9. In the above circumstances I would like to request you to kindly take immediate and necessary action against the aforesaid persons for such type of illegal activities and to

save my land from encroachment.
