I, Anand Raj Pradhan, s/o Mani Raj Pradhan, resident of Tirpai Road, Tirpai Bazar, Kalimpong, currently residing at Atisha Road Fatak, Upper Cart Road, Ward No-19, Kalimpong - 734301, West Bengal; registered owner of the Ambulance bearing No. Wb-78-4321 (OMNI BS IV) would like to bring few lines of distress before you;

- That I am the registered owner of the Vehicle bearing No. Wb-78-4321 which has been plying as an Ambulance in Agreement with the Kalimpong District Hospital, since 2011.
- 2. That on the 23th of March 2022, at around 9.30 pm my vehicle driver Abshek Biswakarma, s/o Deepak Biswakarma, had been contacted by one of the family members of Anisha Rai, who had been admitted in the Kalimpong District Hospital Maternity ward. Their patient had been referred for better treatment from the Kalimpong District Hospital, maternity ward to North Bengal Medical College & Hospital (NBMC&H) at Siliguri, District Darjeeling.
- That after all the referral formalities had been completed by the Kalimpong District Hospital the ambulance left for North Bengal Medical College & Hospital (NBMC&H) at Siliguri, District Darjeeling at around 10.30pm.
- 4. That Abshek Biswakaram had last called me at 10.30pm informing me about him leaving for NBMC&H at Siliguri, with a patient who was pregnant and two other family members as they had been referred from the Kalimpong District Hospital to the North Bengal Medical College & Hospital at Siliguri.
- 5. That yesterday i.e 24th March 2022 at 4.30 am 5.00 am I received a phone call from an unknown number (+919382309371). He informed me that he had received a call from the Kalimpong P.S. regarding an Ambulance meeting with an accident at Naukaghat, but was unsure if it was my vehicle in concern, and advised me to enquire with the driver Abshek Biswakarma.
