Sir,

With due respect, I am producing herewith 01 (One) arrested accused person namely Debasish Das (24 yrs) S/O late Debu Das of Simultala, PS- Matigara, Dist.- Darjeeling under arrest and 01 improvised Automatic small Fire arm measuring approx 21 CM in Length including its 10 CM butt having trigger, trigger guard, firing pin & firing Hammer and Magazine loaded with 01 (one) rounds of ammunition and marked as Exhibit "A" & Exhibit "B" recovered from the possession of the above noted accused. The ground of arrest duly been communicated with him.

I SI Goutam Mallik of NJP PS, SPC do hereby lodge this written complaint against the arrested accused person namely Debasish Das (24 yrs) S/O late Debu Das of Simultala, PS- Matigara, Dist.- Darjeeling. In this regard, I beg to report that today i.e. on 26.03.22 at 13.55 hrs I received a secret information that one Debaish Das of Matigara is moving at near Bhalobasha More under PS- NJP, Dist.- Jalpaiguri with one automatic fire arms loaded with live ammunition most probably for committing heinous crime at the locality. Accordingly, I Diarised the information in General diary vide NJP PS GDE No 1192 dated 26.03.2022 and informed the fact to the officer-in-Charge, NJP PS. As per kind order and direction myself along with ASI Khagen Barman, ASI Sajal Das, C/1053 Pares Rava, HG/794 Ranjit Roy, VP/13 Jamirul Islam, VP/08 Laxman Roy and CV/306 Bisawajit Roy all of NJP PS, SPC left for Bhalobasha More under PS-NJP, Dist.- Jalpaiguri with investigation kit to work out the information in hand by Govt. vehicle vide NJP PS GDE No 1192 dated 26.03.22 and MCC No 1091/22 dated 26.03.22. We reached at the spot i.e. Bhalobasha More under PS NJP, Dist.- Jalpaiguri at about 14.25 hrs and as indicated by the source we able to apprehend one person. On being asked he disclosed his identity as noted above. As per source information, that he possessed improvised fire arms and ammunition. Hence, immediately I searched the detained person and found 01 improvised Automatic small Fire arm measuring approx 21 CM in Length including its 10 CM butt having trigger, trigger guard, firing pin & firing hammer and Magazine loaded with 01 (one) rounds of ammunition which accused kept concealed in his waist. He exclusively possessed improvised fire arm loaded with live ammunition illegally. On demand he failed to produce any document in support the said improvised fire arm and live ammunition which has been found in his possession. Thus when his involvement in carrying and possessing illegal fire arm and live ammunition was established, I seized that improvised fire arms and 01 (one) round of live ammunition under proper seizure list duly acknowledged by the accused person and marked as Exhibit "A" & Exhibit "B". The search and seizure made in between 15.25 hrs and 16.05 hrs on 26.03.22 and arrested him by preparing memo of arrest informing him about the ground of arrest.

Under the above noted facts and seizure of incriminating articles there is strong reason to believe that the said accused person namely Debasish Das (24 yrs) S/O late Debu Das of Simultala, PS- Matigara, Dist.- Darjeeling is desperate and dangerous in nature, as he was carrying the said fire arm and ammunition with an objective to commit heinous crime in the locality.

As he willfully violated the regulation of Arms Act, So, I pray before you for starting a case against the arrested accused person namely Debasish Das (24 yrs) S/O late Debu Das of Simultala, PS- Matigara, Dist.- Darjeeling under appropriate section of law and arrange for its investigation.
