I Smt Jaba Barman, Wife of Sri Bikash Mondal, D/O Shri Jagadish Barman, permanent resident of Prankrishna Colony, Deshbandhu Para, Ward No.28 of S.M.C, P.O. & P.S. Siliguri, Dist. Darjeeling and presently residing at the same address under the care and custody of my parents.

I do hereby inform you that I was married to Shri Bikash Mandal, S/O Shri Swapan Mandal, permanent resident of Dhaulaguri, Charerbari, P.O. & P.S. Maynaguri, Dist. Jalpaiguri as per Hindu rituals and customs in presence of friends, kiths, kins, relatives of both the parties and the said marriage was solemnized on the date of 21st June, 2019. The marriage was a negotiated one.

Soon after marriage I was subjected to severe mental and physical torture by my husband and my in laws. I was subjected physical beating by my husband when my father-in-law Swapan Mandal complained one day that I had stolen the money from the packet of biri where my husband usually keeps his daily earnings. More over the whole family including husband Bikash Mandal, father-in-law Swapan Mandal, Mother-in-law Pratima Mandal, Sister-in-law Shibika Mandal has beaten me mercilessly and my sister in law Shibika Mandal has stolen all of my gold ornaments (streedhan) given by my paternal family at the time of marriage. My Husband Bikash Mandal used to beat me in a drunken state and used to tie my mouth with gamcha so that I cannot shout out of pain and the neighbors cannot hear me screaming in pain while he beats me. On the next day of such inhuman torture I was ousted from my matrimonial house i.e. on 14.10.2020 while I was pregnant, i.e. I was tortured while I was pregnant.

I gave birth to a male baby child was born on 16th April 2021 named Diyan Mandal on North Bengal Medical College and Hospital.

The good name of my child is not surely known to me as my husband came to visit me at my paternal house and took the application of birth of child and it is under his custody however we call the child "Diyan Mandal". While my husband visited my paternal house on 3rd June he tortured me both physically and mentally and left me and never came back.

I thought that after the birth of our child and with passage of time my husband would take me from my paternal house to the matrimonial house and would care for me but all my expectations went in vain.
