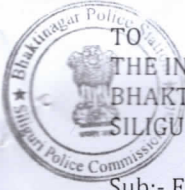

Sir,

In producing here with the one arrested accused person namely Madan Limbu s/o Late Iman Limbu of Chota Fapri, Near Kali Mandir, Dabgram II Anchal, PS Bhaktinagar, Dist Jalpaiguri along with the following seized articles as per proper seizure list:

- 1] Twenty (20) Bottles of Himalayan Gold 60 up Country Spirit each Bottle containing 600ml.
- 2] Ten (10) Bottles of Officer's Choice Deluxe Whisky each bottle containing 180 ml.
- 3] One Multicolour Nylon handbag in which the above noted seized articles were kept.

I, SI Sk Tamzid Ali of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 28.03.2022 at about 14.30 Hrs I, received a source information that the above noted accused person has possessed huge amount of Liquor in a Nylon Carry bag for clandestine disposal of the same and was waiting for toto near Sriraj Shyam Steel Company, Eastern Bypass road under Bhaktinagar PS. This refers to Bhaktinagar PS GDE No. 1828, Date. 28.03.2022. Accordingly the information shared before you and as per your kind direction I along with Constable C/762 Debraj Biswas, CVF-619 Dharmendra Roy headed towards Eastern Bypass Road to verify the veracity of the information. At about 14.45 Hrs we reached at By pass Road and as shown and being identified by the source apprehended one person who was carrying one nylon multicolour carry bag and who disclosed his identity as noted above. Further maintaining his decency and observing all formalities searched inside the bag and recovered huge amount of above noted seized liquor. On demand he could not produce any valid documents/licence in respect of the recovered liquor. On enquiry the apprehended person admitted his guilt and confessed that he has possessed above noted liquor for the purpose of selling to his designed customers for his wrongful gain. He also stated that he has been doing this act illegally since long without any valid licence or Documents for his wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made between 15.05 Hrs to 15.35 Hrs. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your kind honour that a specific case may kindly be registered against the accused person namely Madan Limbu s/o Late Iman Limbu of Chota Fapri, Near Kali Mandir, Dabgram II Anchal, PS Bhaktinagar., Dist Jalpaiguri under proper section of law and arrange for its investigation.
