With due respect, I, Sri Rajesh Kumar Yadav, S/o Sri Banarasi Yadav, resident of Ganga Nagar, Ward No - 5, P.O - Siliguri Bazar, P.S - Siliguri, District - Darjeeling would like to inform you that I am the registered owner in possession of land recorded in Khatian No - 167, having Plot No - 2120 (part), J.L No - 110 (88), under Mouza - Siliguri, Paragana - Baikunthpur, SMC Ward No - 4, P.S - Siliguri, District - Darjeeling, and since some time one Binod Paswan, Sri Pramod Paswan both are S/o Sri Parmeswar Paswan, Abhishek Paswan S/o Binod Paswan and Parmeswar Paswan all are resident of Maharaj Colony, P.O. - Siliguri Bazar, P.S.- Siliguri, District - Darjeeling, Sri Jitendra Prasad S/o Biswanath Prasad resident of Santoshi Nagar, Ward No - 5, P.O & P.S - Siliguri, Sri Mayanath Gour @ Final S/o Raja Ram Gour of Khalai Bhaktri, P.S - Matigara, District - Darjeeling, Md. Azad S/o Md. Shehzad of Basu Colony Ward No - 4, P.O & P.S - Siliguri, District - Darjeeling, Sri Sumit Mishra S/o Not Known, resident of Chanapatty, ward No - 6, Siliguri, Darjeeling, Sri Bimal Biswas S/o Not known, resident of Santoshi Nagar, ward No - 5, P.O & P.S - Siliguri, District - Darjeeling and 4-5 persons are disturbing my possession over the land and finding no other alternative on 9 - 12 - 2019 I have filed one civil suit having Title Suit No - 242/2019 before the Ld. Civil Judge, Jr. Division, at Siliguri and after hearing, the Ld. Court was pleased to pass ad-interim injunction against the above named persons.

Be, it mention here that inspite of having the order of injunction the above named persons, still disturbing my possession, by this and that for the reason best known to them and still they are trying to grab my property.

Today i.e. 30 - 3 - 2022 at about 9.30 A.M. I had been to my landed property for my personal work and by seeing me the above named persons became furious and have started abusing me in filthy languages and tried to restrain me from entering my own landed property and when I have put my objection on the pleading that the case is pending against all of you before the Ld. Civil Judge (Jr. Division) the above named persons have attempted to assault me and wit intention to injure me grievously, they have started collecting iron rod, lathi and bamboo sticks and have confined me in their circle but I any how managed to escape from their said attempt and when I have started fleeing from my landed property, they have chased me with threatening that if I dare to come in my land they will break my limbs and if needed they will kill me. At the time of my arrival at my landed property, I found that the above named persons in utter violation of Injunction order of the Ld. Court, they have placed their vehicles in my land not only that they have also with intention to grab my landed property have

put one sign board in my landed property. They above named persons are very dangerous and they have no regard in law and if they got chance they will not hesitate to kill me.

So, requesting you to investigate the matter and take necessary legal action against the above named persons for the interest of justice.
