In producing herewith three (3) accused persons namely i) Prakash Chhetri 19 yrs s/o Jambu Chhettri of Daragaon PO+PS, Bagdogra Dist, Darjeeling ii) Ajit Kr. Tiwari 24 yrs S/O Lt. Shila nath Tiwari of Prakash Nagar ps Bhaktinagar Dist. Jalpaiguri and iii) Bijoy kr. Mahato 20 yrs s/o Kapil Mahato of New Prakashnagar ps. Bhaktinagar Dist. Jalpaiguri along with seized articles viz

1. One iron made improvised "One Shutter pipe gun " fire Arms measuring approx its length 22.6 cm including butt body and barrel from the possession of accused Prakash Chhetri
2. One live .303 ammunition measuring approx 7.6 cm from the possession of accused Prakash Chhetri
3. One iron made sharp cutting hand dha (Hasua) having its length 9 inch with wooden butt length 7 inch from the possession of accused Bijoy kr. Mahato
4. One 16 MM iron rod measuring its long approx 33.5 inch from the possession of accused Ajit Kr. Tiwari
5. One knife having length 10 inch from the accused Ajit Kr. Tiwari

I SI Dipanjan Bhadra, Bagdogra PS, SPC do hereby lodge a written complaint against the above noted arrested accused persons to the effect that **on 31.03.2022 at 21.50 hrs** received a secret source of information to the effect that 08/09 miscreants armed with deadly weapons assembled in a dark place at Taipoo more beside NH-31 road under Bagdogra Ps with a view to commit road dacoity. Accordingly without waste any time, I informed the matter to you and diarized the matter vide Bagdogra PS GDE No 1895 dt. 31.03.2022 and as per your kind instruction myself along with ASI Dharendra Nath Mandal, ASI Jakirul Islam, CV-386 Kishor Ranjan Hawilder CV-375 Jogesh Barman VP-01 Anselam Kujur, HG-1187 Sushil Roy, CV/390 Sampad Singha left from PS, for Taipoo more beside NH-31 road to verify the veracity of the information and to work upon it vide Bagdogra PS, GDE No 1896 Dtd, 31.03.2022 . We reached near the spot as confirmed by the source at about 22.10 hrs and stopped out vehicle at a considerable distance Taipoo more beside NH-31 road and we started walking towards the road side and we reached at Hansqua area found a group of 08/09 persons assemble and gossiping there beside the NH-31 road. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang sees the police. Somehow, after a hot chase we could able to apprehend the 03 ( three ) persons noted above and the others 04/05 persons managed to flee away from the spot . On interrogation they disclosed their identity and they also stated that they along with their other associates assembled there with a view to commit road dacoity to goods truck or Kolkata Bihar bound bus after making full preparation. Thereafter all the apprehended persons were searched and due to late night could not found any independent witness to present at the time of search and seizure. During searching, the above noted articles were recovered with deadly weapons recovered from their individual possession and seized the same as per proper seizure list duly sign by them. Accordingly, I arrested the above noted accused person u/s 41 Cr.P.C. The seizure made in between 22.25 hrs to 23.05 hrs and the all the persons were arrested with proper memo of arrest inform their ground of arrest.

So I pray before you that a specific case may kindly be started against the 03 ( three ) accused persons namely and 04/05 other persons and arranged for its investigation.
