Respected Sir,

- I, **SRI DHRUBA ROY,** Son of Bidhan Roy, Resident of Indirapally, Sibmandir, Post office Kadamtala, Police Station Matigara, District Darjeeling, the undersigned would like to bring to your kind notice and state as follows:
- That I am an employee of BIRLA DIVYA JYOTI SCHOOL, Zone F, Uttorayon, Matigara, Siliguri, District Darjeeling and I was appointed as a Teacher in the said School on 06.04.2011, initially on probation and thereafter as a permanent teacher on and from 01.04.2013.
- 2. That I was appointed as a teacher of Physical Education for the classes II to Class X and I have been most diligently performing my duties without any negligence or latches. I have also received leave encashment benefit from my School for my consistent performance.
- 3. That even during the Covid 19 nationwide lockdown period, I have regularly taken online classes without any default and have also participated in various academic competitions held on all India basis and have received number of prizes and recognitions.
- 4. That recently the Principal of the said School, namely **Smt. Shweta Tiwary** has been harassing me in various ways. And creating disturbance in performing my duties. She had engaged me to do various other works including engaging me in teaching computer, taking work education classes, checking computer test copy, etc. However I never objected to such jobs being given to me and I have also diligently performed all by duties without any negligence.

- 5. That inspite of my diligent performance with no bad record whatsoever, the said Smt. Shweta Tiwary, Principal of my said School is harassing me and due to such torture I am unable to perform my duties and she has also threatened me and insulted me on number of occasions without any reason whatsoever.
- 6. That on 15.03.2022 the said **Smt. Shweta Tiwary**, called me to her office and insulted me and abused me in filthy languages including abusing me with regards to my cast as I belong to a Schedule Cast Community. She also stated that she doesnot want any person belonging to the Schedule Case community to remain as a teacher in the said School and asked me to submit my resignation immediately and failing which she has threatened me with severe consequences.
- 7. That even on earlier occasions the said **Smt. Shweta Tiwary**, has insulted me and abused me calling me to be a person belonging to lower cast and had cast inhumane torture upon me.
- 8. That the said **Smt. Shweta Tiwary** has also forced various faculty members to submit their resignation and leave their jobs and the said faculty members out of fear of false acquisitions has left their jobs.
- 9. That I had been undergoing such inhumane torture for the last few months in fear of losing my job, but I am unable to bear such inhumane torture any further and have been compelled to approach your goodself for redressal.
- 10. That it transpires from the act of torture and continuous harassment of said Smt. Shweta Tiwary, that she had since long hatched up a conspiracy to oust me and dismiss me from my job and she intends to give the said job to some of her favourable person and for illegal gain.
- 11. That owing to such torture I suffered severe mental trauma and had undergo medical treatment for treatment of depression.

In view of the above facts and circumstances, it is humbly prayed that your goodself would be kind enough to enquire and investigate into the matter and take necessary action against the aforesaid person, namely SHWETA TIWARY and do the needful in this regard.
