Respected Sir/Madam,

I, **SRI GOURI SHANKAR GOYAL** alias Agarwal S/o Late Omprakash Agarwal @ Goyal, Hindu by Religion, Indian by Nationality, Business by occupation, Resident of Agrasen Road, Khalpara, Siliguri, P.O. & P.S. Siliguri in the District of Darjeeling, would like to lodge a complaint stating the following facts:

1. That I along with three others had acquired the total land measuring 136 Decimal in R.S. Plot No. 634 corresponding to L.R. Plot No. 838 & 841 of Sheet No. 1 (One), recorded in R.S. Khatian No. 56/13 of Mouza – Ambari Falakata by virtue of several Deed of Conveyance being No. 1365, 1407, 2087 and 2077 all for the year 2006 executed by Pratul Kr Chaki or his subsequent purchaser.

It is pertinent to mention here that land measuring 36 Decimal was acquired by the Government of west Bengal for the NH Highway and the award was rewarded in favour of me and my Co-sharer.

2. That subsequently it came to our knowledge that one Pratul Kumar Chaki who was our predecessor in interest is negotiating to sell the land to Aluddin Mohammad and Phajiraddin Mohammad and a settlement was entered into with the said Aluddin Mohammad and Phajiraddin Mohammad and on the same day, i.e 12<sup>th</sup> February, 2015 Pratul kumar Chaki transferred land measuring 126 Decimal in R.S. Plot No. 634 corresponding to L.R. Plot No. 838 & 841 recorded in R.S. Khatian No. 56/13 of Mouza – Ambari Falakata to Aluddin Mohammad and Phajiraddin Mohammad by Deed No. 352 for the year 2015 who transferred the said land in my favour by Deed No. 358 for the year 2015, registered at the office of DSR Jalpaiguri.

3. That my co-sharer then transferred their share in the land in favour of my relatives vide Deed of Conveyance No.1746, 1749 for the year 2016 and 3829 for the year 2017.
