We're saddened to report an incident which took place on 24th March 2022 in the evening at our sec no 33Y. Around 2000 Sqft. areas planted with approx. 100 Tea Bushes were burnt and which are not able to survive anymore and which cause losses to the Garden.

There have been quite a number of cases in our surrounding area for the past few weeks. We have earlier reported the same incident on 28th February 2022 but culprit is not yet identified.

Since it is a matter of our safety, I request to look into this matter and take the necessary action at the earliest. Looking forward to your kind assistance in this matter.

It is prayed that an FIR may kindly be registered and the accused be arrested and brought to the books and tried as per law.
