I, Parveen Banu, daughter of Late Md. Naimuddin, resident of South Ambedkar Colony, VIP Gali, Ward No. 1 of Siliguri Municipal Corporation, Siliguri, Post office and Police Station- Pradhan Nagar would like to state that my neighbor were regularly asking my mother to sell our house to them but my mother rejected their proposal. Today at around 9.30 A.M. when my brothers went out for work my neighbor namely sakib, Afgal, Intiaz, sabbir and his father came to my house and started threatening about consequences if I don't sell them our house to which some verbal altercation started in which my said neighbor started physically abusing my mother and when I protested they started using slang language at us, physically abusing and molestating us later they grab the head of my mother and hit it in drain causing severe head injury and she has to be admitted in Siliguri District Hospital.

Sir, I request you to take necessary action against the said person and save us from their inhumane behavior, physical and mental torcher and daily verbal and physical abusive as per law against the said persons as per law.
