At around 2.30 pm in the evening I was informed by the
son of my client namely "Laxmi Sabom" that she was physically
assaulted by her husband and for being injured by such assault
she was brought to Odisha Sadar Hospital and therefore I was
informed by her son to come to the上述 hospital and
file a written complaint on her behalf, accordingly on course of
my legal duty towards my client, I went to the Odisha
Sadar Hospital premises along with my law clerk, Tolon Das,
Son of late Chittaranjan Mahanta Pathy, P.S. Mahagna, District
Dharmapuri.

But when we entered the premises of Odisha Sadar Hospital,
Suddenly a total of ten (10) Dr. doctors (10) people goaded

by two men and a woman surrounded us and started threatening us with dire consequences not to engage ourselves into their matter and force fully resisted and wrongfully confined us to prevent us from meeting our client, when we protested, the mob started assaulting us with fist and blows, on the very moment, one of them snatched my 'Gold Chain' along with my 'mobile phone', one of my dearest colleague saw the incident and immediately informed others, thereafter many of our colleagues arrived at the spot and we were somehow rescued by them, immediately the Siliguri Police Station was informed and Police came to the spot. In few minutes thereafter,
