In producing herewith two (02) arrested accused persons namely (i) Hitesh Singha (21) s/o Pathin Singha of Dimajote, PO Nemai, PS Matigara, Dist Darjeeling (ii) Subhankar Roy (23) s/o Bablu Roy of Himul Bhangapool, PO Nimai, PS Matigara, Dist Darjeeling (not verified) along with the following articles under proper seizure as per seizure list;

a) One red colour Pittu bag styled as 'Adidas' containing 30 (Thirty) bottles of "ETHCOREX-CD" Cough Syrup (each bottle containing 100 ml) having Batch No. NLA 2313 Mfg. Date: 01/2022. Exp. Date: 12/2023 - seized from the possession of above noted Hitesh Singha and marked as "Exhibit- A".

b) One (01) bottle of "ETHCOREX-CD" Cough Syrup (containing 100 ml) randomly taken from "Exhibit- A" for

examination and marked as "Exhibit A-1".

c) One blue neon colour Pittu bag styled as 'Adidas' containing 30 (Thirty) bottles of "ETHCOREX-CD" Cough Syrup (each bottle containing 100 ml) having Batch No. NLA 2313 Mfg. Date: 01/2022. Exp. Date: 12/2023 seized from the possession of above noted Subhankar Roy and marked as "Exhibit- B".

d) One (01) bottle of "ETHCOREX-CD" Cough Syrup (containing 100 ml) randomly taken from "Exhibit-B" for

examination and marked as "Exhibit B-1".

I, SI Abhishek Theengh (32), S/O- Sri Suchandra Kumar Theengh of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused persons namely Hitesh Singha (21) s/o Pathin Singha of Dimajote, PO Nemai, PS Matigara, Dist Darjeeling and Subhankar Roy (23) s/o Bablu Roy of Himul Bhangapool, PO Nimai, PS Matigara, Dist Darjeeling (not verified) to the effect that on 01.04.2022 at about 13:25 hrs I received a specific source input that two person possessing huge quantity of 'Codeine Phosphate' based drugs was standing at Himul 2 No. Gate near Mother Diary under Matigara PS to sell the same to their designed local customers. The matter was diarized in Matigara PS GDE No. 25 Dt. 01.04.2022 and subsequently, I informed the matter to the Officer-in-Charge, Matigara Police Station in written and being directed, myself along with ASI Nitai Mandal, ASI Tapan Das, Const- 1035 Santosh Rabidas, Const- 1008 Kanak Roy, Const- 986 Rajib Sarkar, CV-155 Sukumar Das and CV-387 Sukumar Barman all of Matigara PS, SPC along with investigation kit left for Himul 2 No. Gate near Mother Diary under Matigara PS by Govt. vehicle to verify the veracity of the information. This refers to Matigara PS GDE No. 26 Dt. 01.04.2022 and M.C.C No-855/2022 Date- 01. 04.2022.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On way to Himul 2 No. Gate near Mother Diary under Matigara PS I contacted two persons namely (1) Bhagirath Barman (25) S/O Jagadish Barman of Ghoklajote, P.O + P.S- Matigara, Dist- Darjeeling and (2) Dipak Barman (28) S/O Lt. Rajen Barman of Tarijote, Balason, P.O New Rangia, PS- Matigara, Dist-Darjeeling and made them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter, we along with above noted independent witnesses arrived at Himul 2 No. Gate near Mother Diary under PS- Matigara at 13.55 hrs and subsequently, being pointed by my source detained 02 (two) persons standing at Himul 2 No. Gate near Mother Diary. Each of them had carried pittu bag under their possession. Thereafter, we disclosed our identity and the information in hand and stated them that both of them as well as the bag under their possession will be searched for the purpose. And, I gave them option in writing to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which they agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused persons to search our Police Party as per provisions but, they did not search the police party. Consequently, I informed the matter to O/C Matigara PS and as per his kind order, I informed to Shri Pasang Topgay Bhutia, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused persons suspected to be possessed 'Codeine Phosphate' based drugs illegally and requested him to come at Himul 2 No. Gate near Mother Diary under Matigara PS to remain present and to supervise the search and seizure.

Accordingly at 14.35 hrs Shri Pasang Topgay Bhutia, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC arrived at the spot at Himul 2 No. Gate near Mother Diary under Matigara PS as Special Executive Magistrate, SPC and in presence of two independent witnesses I searched the detained persons following all formalities, keeping their decency and recovered the above noted articles from the exclusive and conscious possession of the accused persons namely (i) Hitesh Singha (21) s/o Pathin Singha of Dimajote, PO Nemai, PS Matigara, Dist Darjeeling (ii) Subhankar Roy (23) s/o Bablu Roy of Himul Bhangapool, PO Nimai, PS Matigara, Dist Darjeeling (not

It has been found from the bag under the possession of the above noted accused person namely Hitesh Singha containing 30 (thirty) bottles of "ETHCOREX-CD" cough syrup (each bottle containing 100 ml) containing 30 X 100 ml = 3000 ml i.e., equivalent to 3 Kg.

And It has been found from the bag under the possession of the above noted accused person namely Subhankar Roy containing 30 (thirty) bottles of "ETHCOREX-CD" Cough Syrup (each bottle containing 100 ml) containing 30 X 100 ml = 3000 ml i.e., equivalent to 3 Kg

Further, on demand in presence of Shri Pasang Topgay Bhutia, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC. The detained persons namely Hitesh Singha & Subhankar Roy failed to produce any valid documents/papers or explanation for possessing of such a huge quantity of 'Codeine Phosphate' based drugs beyond the prescribed limit.

Thereafter, I seized the recovered 30 (thirty) bottles [containing 3000 ml i.e., equivalent to 3 Kg] of ETHCOREX-CD Cough Syrup [including 01 (one) bottle of ETHCOREX-CD Cough Syrup (each containing 100 ml) which were taken randomly from the mother packet for examination from the exclusive and conscious possession of above noted accused person namely Hitesh Singha & 30 (thirty) bottles [containing 3000 ml i.e., equivalent to 3 Kg of "ETHCOREX-CD" Cough Syrup [including 01 (one) bottle of "ETHCOREX-CD" Cough Syrup (each containing 100 ml) which were taken randomly from the mother packet for examination] from the exclusive and conscious possession of above noted accused person namely Subhankar Roy at the spot at Himul 2 No. Gate near Mother Diary under Matigara PS under proper seizure list in presence of independent witnesses and Shri Pasang Topgay Bhutia, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC obtaining their signature and being acknowledged by the accused persons.

Subsequently, I labelled and sealed the seized articles in presence of Shri Pasang Topgay Bhutia, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC and independent witnesses and the accused persons namely Hitesh Singha & Subhankar Roy. The whole process of seizure was made in between 14.40 hrs to 15.45 hrs.

Being further asked, the apprehend persons namely Hitesh Singha & Subhankar Roy admitted in presence of Shri Pasang Topgay Bhutia, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC and other independent witnesses that they have procured the Codeine Phosphate based drugs clandestinely for the purpose of selling the same in high rate to his designed local customers for their personal gain by illegal means. They also disclosed that they have been dealing in this business of procuring and selling of 'Codeine Phosphate' based drugs illegally for last few months for his wrongful gain.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons namely Hitesh Singha & Subhankar Roy are involved in procuring and selling 'Codeine Phosphate' based drugs illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused persons namely Hitesh Singha & Subhankar Roy after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely (i) Hitesh Singha (21) s/o Pathin Singha of Dimajote, PO Nemai, PS Matigara, Dist Darjeeling (ii) Subhankar Roy (23) s/o Bablu Roy of Himul Bhangapool, PO Nimai, PS Matigara, Dist Darjeeling (not verified) and arrange for its investigation.
