With due respect and humble submission I beg to state that the above referred case had been started on the basis of written complaint of Pali Biswas W/O Shibu Biswas of Dakshin Santinagar, Binoy More, P.O - Dabgram, PS NJP, Dist Jalpaiguri to the effect that her marriage was solemnized since 15 years with one Shibu Biswas S/O Lalit Biswas of Dakshin Santinagar, Binoy More, PO-Dabgram, PS NJP, Dist - Jalpaiguri as per Hindu rituals. After her marriage she was subjected to torture both mentally and physically by her husband and in laws. In their weed look she gives birth two children. She also noticed that her husband had an illicit relationship with another woman. On protest her husband more torture to the complainant. Even on 17/11/21 the complainant was driven out from her husband's house along with her children by her mother-in-law namely Smt. Swapna Biswas , finding no other alternative, took shelter at her parental house situated near I.O.C gate, Bhaktinagar.

During investigation of the case It could be learnt that the case comes under the jurisdiction of the Bhaktinagar PS, Siliguri Police Commissionerate. Hence, I pray before your kind honour that necessary order may kindly be accord to hand over the case to Bhaktinagar PS, Siliguri Police Commissionerate for the fair and speed investigation of the case.
