In producing herewith one arrested accused person namely Biswas Chhetri @Abdul (34) S/o Gopal Chhetri of Farabari, Nepali Busty, P.O-Sahudangi hat, PS-NJP, Dist-Jalpaiguri who has been arrested u/s- 41 Cr.P.C along with the following seized articles viz-

1. One (01) improvised fire-arms with magazine, iron made having length about 20 cm with body, trigger, firing pin, barrel and fibre-fitted butt having marked with " Mica, Sun, INDUSTRIAL", packed, labelled & sealed as Exhibit -A
2. One (01) pcs of live Ammunition having marked "7.65, K.F" at the base of the cartridge, packed, labelled & sealed as Exhibit -B

I, SI Kamal Ch. Saha of Ambari-Falakata Out Post, Ps-NJP, SPC do hereby submit this written complaint against the above noted accused person to the effect that, on 01.04.2022 during my mobile van patrolling duty, I have received a specific reliable source information that, one person is loitering with illegal arms which is concealed in his person near Pradhanpara More, Farabari, Nepali Busty. Therefore, I conveyed the same to O/C, Ambari-Falakata OP and as per his direction I along with mobile van force NVF/131 Bidhan Roy & NVF/108 Swadesh Roy all of Ambari-falakata OP, Ps-NJP, SPC left for Pradhanpara More, Farabari, Nepali Busty to verify the veracity of the information. At about 18.15 hrs we have reached near Pradhanpara More, Farabari, Nepali Busty and meanwhile called one independent witnesses namely Rakesh Chhetri S/o Gyan Kumar Chhetri Of Farabari, nepali Busry, P.O-Sahudangi hat, Ps-NJP, Dist- Jalpaiguri and disclosed our identity and informed him about the information and requested him to accompany us in the whole process during search and seizure, if any. Being accompanied by source and the witness our whole police party started keeping watch over people near Pradhanpara More, Farabari, Nepali Busty. At around 18.35 hrs on being identified by the source we have apprehended one suspected person who, during interrogation, disclosed his name & identity as noted above.

Therefore, I have searched the above noted suspected person in presence of the said witness and recovered one fire arms from the possession of Biswas Chhetri @Abdul which was kept concealed in his right waist & one round of ammunitions in his right pocket. On being asked he failed to produce any valid license in respect of possession of such gun. On being demand he failed to justify for carrying the said Fire Arms. On further interrogation he stated that he had procured the said fire arms illegally with intend to sale for his wrongful gain. His movement was suspicious and he could not able to even clarify his alibi and status why he is moving in this area. Myself with the help of my team and in presence of local witness searched him but found nothing except fire Arms & ammunitions.

Accordingly, I seized (i) One (01) improvised fire-arms with magazine, iron made having length about 20 cm with body, trigger, firing pin, barrel and fibre-fitted butt having marked with " Mica, Sun, INDUSTRIAL", (ii) One (01) pcs of live Ammunition having marked "7.65, K.F" at the base of the cartridge under proper seizure list duly signed by the witnesses and accused person and packed, labelled, & sealed the arms & ammunition separately on the
