In producing here with the one arrested accused person namely Shyamal Bsak (40) s/o Late Hemanta Basak of Haiderpara, Ward no 40, Anandamaye Kalibari Road, PS Bhaktinagar, Dist. Jalpaiguri along with the following seized articles as per proper seizure list:

1] Eighteen (18) Bottles of 60 UP Himalayan Gold Country Spirit each bottle containing 600 ml. 2] Five (05) Bottles of 70 UP Country Spirit, Himalayan Fata Fati each Bottle containing 300ml.

3] One multicolour Nylon Carry Bag in which the above articles was kept.

I, PSI Sailesh Subba of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 07.04.2022 at about 17.35 Hrs while performing evening raid duty I, received a source information that the above noted accused person has possessed huge amount of Liquor in a Nylon Carry bag for clandestine disposal of the same and was standing at Isckon Mandir Road, near Anchal Office under Bhaktinagar PS. This refers to Bhaktinagar PS GDE No. 279, Date. 07.04.2022. Accordingly the information shared before you and as per your kind direction I along with Constable C/762 Debraj Biswas, CVF-014 Labanyamoy Barman of Bhaktinagar PS left PS and headed towards Isckon Mandir Road to verify the veracity of the information. At about 17.45 Hrs we reached at Isckon Mandir Road and as shown and being identified by the source apprehend one person who was carrying one nylon multicolour carry bag and on being asked about his name and address he disclosed his identity as noted above. Further maintaining his decency and observing all formalities searched inside the bag and recovered huge amount of above noted seized liquor. On demand he could not produce any valid documents/licence in respect of the recovered liquor. On enquiry the apprehended person admitted his guilt and confessed that he has possessed above noted liquor for the purpose of selling to his designed customers for his wrongful gain. He also stated that he has been doing this act illegally since long without any valid licence or Documents for his wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made between 18.05 Hrs to 18.35 Hrs. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your kind honour that a specific case may kindly be registered against the accused person namely Shyamal Bsak (40) s/o Late Hemanta Basak of Haiderpara, Ward no 40, Anandamaye Kalibari Road, PS Bhaktinagar, Dist. Jalpaiguri under proper section of law and arrange
