Sub: FIR against stealing inside M/S Swastik Plastic Industries, WBSIDC sector

I hereby write this letter to bring to your kind attention that, since last 3-4 months I have been travelling with my wife to get her medical treatment as she is diagnosed with an immense unfortunate medical state and I was not in a position to visit my workplace M/S Swastik Plastic Industries situated at Dabgram Industrial Park, WBSIDC section, Dist. Jalpaiguri on regular basis and also could not concentrate on details of working operations.

Sri Umesh Mahato and Sri Krishna Sarkar, two of my veteran and prime employees, have been entrusted with supervise, take care of day-to-day works of my industrial Unit in my absence.

Yesterday I visited my Unit and to my utter surprise I found many of my valuable spare equipment, moulds are missing from my storage space. The industrial moulds being not of regular use category and were necessary for seasonal use and normally being kept in store for usage as required.

A preliminary estimate being assessed for the missing moulds and other equipment as worth to the tune of Rs.20 lakhs. My in house CC TV surveillance cameras were also not functioning.

I would also like to mention that Sri Krishna Sarkar was absent from his duty for last one month and on investigation it was revealed that Sri Krishna Sarkar could have direct link with the pilferage of valuable machine parts and the wife and other members of family of Sri Krishna Sarkar have also complained of involvement Sri Sarkar with some extra marital affairs and other atrocities.

In view of this I would request your good self to conduct an urgent detail enquiry of the matter as explained above and arrange for recovery of my valuable machine parts.
