Subject: - FIR

Sir,

With due respect and humble submission, I would like to inform your good office that on 14.04.2022 I along with force have been detailed to perform L/O duty in c/w Charak Mela at B. Ed College ground under PS Matigara, SPC vide Matigara PS MCC No.566/22, dated- 14.04.2022. In course of duty at 20:20 hrs it is noticed that the Charak Tree fixed at the Mela ground suddenly collapsed on ground resulting some people namely (i) Ramesh Barman, (ii) Ratan Roy, (iii) Lalit Singha, (iv) Biraj Singha got injured. Immediately, I with the help of local people shifted the injured persons to North Bengal Medical College & Hospital for their treatment.

On preliminary enquiry, it is found that the Charak Mela has been conducted by B.Ed College Charak Mela Committee having its President Ajit Kumar Barman, Secretary - Arup Kumar Barman, Cashier- Sanjay Singha. It is further learnt that the Charak Tree which was fixed at the Mela Ground by the concerned committee was very old and the Committee did not take any precautionary measures for conducting the Mela with such old Charak Tree

Hence, it is quite evident that the incident noted above took place for the rash and negligent act on the part of the members of B.Ed College Charak Mela Committee which endangered the human life and safety at the B.Ed College ground during celebration of Chrak Mela.

Under the above circumstances, I pray before your good office that a specific case may kindly be initiated under proper section of law against Ajit Kumar Barman (President), Arup Kumar Barman (Secretary), Sanjay Singha (Cashier) and other involved members of B.Ed College Charak Puja Committee and arrange for its investigation.
