Respected Sir,

I, Smt. Poonam Singh wife of Sri Manoj Singh resident of Uday Shankar Sarani, Ward No.10 of SMC, P.S-Siliguri, District-Darjeeling, having my vacant land situated under the territorial jurisdiction of your Police Station, would like to lodge this written complaint for extortion and physical assault coupled with arms against the following persons,

1. Rama Chetri wife of not known resident Greenpark, Ward No. 46 of SMC, Mallaguri, P.S-Pradhannagar, District-Darjeeling.
2. Jai Prakash Gupta @ Chotka, having mobile no. 7001816027, son of not known resident of Ward No. 46 of SMC, Mallaguri, P.S-Pradhannagar, District-Darjeeling,
3. Sanjay Gupta having mobile no. 906496998, son of not known resident of Ward No. 46 of SMC, Mallaguri, P.S-Pradhannagar, District-Darjeeling.
4. Mintu Bhowal having mobile no. 8617079839 resident of Ward No. 46 of SMC, Mallaguri, P.S-Pradhannagar, District-Darjeeling.

5. Suman Ghosh having 9832679633 Ganesh Ghosh Colony, P.O-Champasari, P.S-Pradhannagar, District-Darjeeling, along with some anti social land grabbers.

The above named accused armed with deadly weapons i.e fire arms/Iron made chopper along with bamboo on 12/04/2022 at about 8:30 A.M to 9:30 A.M they all of a sudden broke padlock on main gate of my land ad-measuring 4 Katha recoded in RS Khatian. 3/3 L.R 50, Plot No. RS. 408, L.R 631, situated within Mouza-Kalkut, J.L no. 44, Pargana-Patharghata, P.S-Pradhannagar, District-Darjeeling, When I learnt the same I rushed to the spot and find the above named persons standing over there, asked me to pay sum of Rs. 500000/- (Rupees Five Lacs) only to secure the land from their hands, firstly I thought it as a Donation of Club, on query as to why I had to pay them such huge amount as till date I have not started my construction works they simply said it is like protection money. When I tried to call my well wisher the accused no. 1 and 3 snatch my mobile phone and assaulted me and accused no. 4 pointed fire arms at me and asked me either to pay the demeaned money or to forget the land, the accused along with others land grabbers took construction material i. e Iron Rods worths Rs. 2 Lacs and 60 bags Star Cement which I unloaded there to start my construction work in this week. Accused No. 1 in connivance with the others have forged some paper and documents by putting false signature and thereby threatening me that She shall file some frivolous case against me and my well wisher.

It is right place to mention here that earlier in the year, 2020 some persons of the locality also tried to grab the land from its owner and for that a specific case was started for its investigation being Pradhannagar P.S Case Nos. 810/2020 and thereafter I have purchased the land from its actual owner but for some financial crisis I could not take the registration of the property but a duly registered General Power of Attorney has been executed to and in my favour being No. 4224/2021 registered at the Office at ADSR-II, Siliguri at Bagdogra.

It is my request to you please do the needful as being a helpless lady the accused are treating me with dire consequence and asked me to forget my land.
