Bhim Kr Chhetri of Cyber Crime PS, Siliguri Police Sir, Commissionerate do hereby lodge a written complaint to the effect that today on 18.04.2022 at about 18.45 hrs while I was engaged in social media monitoring duty at Cyber Crime PS, Siliguri. I found one user of twitter handle "Vijayant Pratap" having url https://twitter.com/Yadu_Kula posted a video showing a clash between the a group of people with comments that "Meanwhile shantipriya #Muslim starting to spread Peace in #Siliguri just now". Accordingly I thoroughly enquired into the matter to find out if any such incident of clash has taken place between two communities at Siliguri and its surrounding areas under Siliguri Police Commissionerate jurisdiction, but came to know that no such incident had taken place.

This clearly indicated that the twitter handle user was circulating fake post in the social media with hatred comments against the particular caste and community to spread communal hatred and disharmony between a particular communities. The user with malafied intention has posted the Video clip in his twitter handle with hatred speech comments and provocations, with intent to cause riot, intentional insult with intent to provoke breach of peace between the communities and promote communal disharmony in the State.

Hence, I pray that a specific case under the relevant sections of law may kindly be registered against the user of the twitter handle mentioned above and arrange for its investigation.
