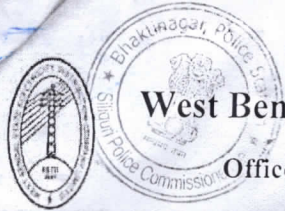

Sir,

I, Sri Manoj Paul, Assistant Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Prasanta Saha (Mob: 7908966366), Himachal Sarani, Hyderpara, Dist- Jalpaiguri for having committed offence as stated here under.

On 26.04.2022 at about 02.50 p.m. acting on a source information I, along with 1) Sri Malay Kr. Goswami, DE(E), S&LP Wing, Darjeeling Region, WBSEDCL, 2) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (3) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the residential building of Susanta Saha and inspected service installation, metering installation of Consumer ID 401808091 in the name of Susanta Saha, which is a disconnected & defaulted service connection. During inspection it was found that present user Prasanta Saha supplying electricity from Con Id. 412058931 in the name of Lt. Ramani Bala Saha unauthorisedly and illegally to disconnected & defaulted premises of Susanta Saha that was disconnected previously on 06.03.2021 due to non-payment of outstanding energy bill.

As unauthorised supply of electricity to the disconnected & defaulted premises was detected the energy meter make Landies & Gyer Ltd, serial no.- L3312084 installed against Con Id. 412058931 seized by preparing a formal seizure list duly signed by representative of Prasanta Saha and witnesses. The copy of the seizure list handed over to representative of Prasanta Saha and his signature obtained as token of receipt.

As Prasanta Saha have committed offence u/s 135(1)(e) of Electricity Act 2003 by supplying electricity illegally & unauthorisedly to the disconnected & defaulted premises, you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
