

Dear Sir,

With due respect I, SRI PAWAN KUMAR AGARWAL, Son of Sri Shivlal Agarwal, resident of Khalpara, Siliguri, P.O. & P.S. Siliguri, District – Darjeeling, would like to draw your kind attention to the following facts which are enumerated herein below in distinct paragraphs -:

The erstwhile owners transferred the possession of the land measuring 1.65 Acre with specific demarcation and presently the constructional works are going on over the said land.
