Sir,

I, Sri Manoj Paul, Assistant Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Pankaj Goswami, S/O- Lt. Paresh Gobinda Goswami, Bipin Paul Sarani, College Para, Siliguri, Dist- Darjeeling for having committed offence as stated here under.

On 26.04.2022 at about 01.50 p.m. acting on a source information I, along with 1) Sri Malay Kr. Goswami, DE(E), S&LP Wing, Darjeeling Region, WBSEDCL, 2) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (3) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the residential building of Pankaj Goswami and inspected service installation, metering installation of Consumer ID 412049605 in the name of Pankaj Goswami. During inspection it was found that electricity was being used unauthorisedly & illegally by Pankaj Goswami by reconnecting the disconnected service line of the metering installation that was disconnected previously on 25.10.2017 due to non-payment of outstanding energy bill.

As unauthorised reconnection of the disconnected service line and metering installation was detected the energy meter make Landies & Gyer Ltd, serial no.- L0902112 installed against Con Id. 412049605 seized by preparing a formal seizure list duly signed by representative of Pankaj Goswami and witnesses. The copy of the seizure list handed over to representative of Pankaj Goswami and his signature obtained as token of receipt.

As Pankaj Goswami have committed offence u/s 135(1)(a) & 138(1)(b) of Electricity Act 2003 by using electricity illegally & unauthorisedly by reconnecting the disconnected service line, you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
