I, S.I. Upen Chettri, of Siliguri PS, Siliguri Police Commissionerate, do hereby lodged this written complaint against one Smt. Niyoti Rabi Das(F/23), W/O- Ruben Rabi Das , of- Pran Krishna Colony, Near Kali Mar tir, W-28, PS- Siliguri, Dist. Darjeeling after producing her under arrest along with following article 20 (twenty) Sealed Bottles Himalayan Gold 60 Up Country Spirit each containing 600 ML, Rs. 120/- each (Total Rs. 2400/-), under proper seizure list, labeling and memo of arrest.

In this regard, I beg to report that on 30.04.2022 at 15.45 hrs, during van duty myself along with LC/- 1295 Swastika Rai, LHG/493 Parul Chakbroty received specific information that the above noted lady accused person is selling huge quantity of illicit Liquor without any valid documents in front of Pran Krishna Colony, Near Kali Mandir. So without making any unnecessary delay I along with Force conducted raid at Pran Krishna Colony, Near Kali Mandir, PS Siliguri, Dist. Darjeeling. During raid found one lady namely Niyoti Rabidas possessing the above noted seized article and selling it to the customers in concealed manner. Subsequently I demanded her the papers or license, cash memo of the said liquor but she failed to produce any documents in support of possession of above noted illicit liquor. On interrogation, she disclosed her name as mentioned above and admitted that she procured the liquor illegally and had been selling the same illegally to the customers. Accordingly seized the illicit liquors in between 16:05 hrs. to 16:35 hrs. in presence of above noted witnesses after preparing proper seizure list duly signed by the witnesses and accused, also labeled the same. Then, I arrested her U/S 41 Cr.P.C after informing her ground of arrest

As the above noted seized articles are to be suspected be of Illicit origin and possessing the same illicitly. I, therefore, pray before you to take legal action against her under proper section of law.
