With due respect, in producing herewith the arrested accused persons namely; (1) Raj Pradhan (30) S/O Thomas Pradhan of Saint Mary Hill, near Bus Terminus, PS Kurseong, Dist. Darjeeling, (2) Sriyanshu Samanta (25) S/O Ajay Samanta of Chadu Uttarpara, near Kali Mandir, PS Tarkeswar, Dist. Hoogly, (3) Abisen Limbu (28) S/O Lt. Bhim Limbu of Singla, Near St. Marys School, PS Sadar, Dist. Darjeeling and (4) Pradhim Rai (24) S/O Rajen Roy of Raigaon, Near Teesta Valley School, PS Rangli Rangloit, Dist. Darjeeling along with seized articles viz:

- 1) 01(One) Golden Colour and 01 (one) Golden and Steel colour Hookah Set it contain Tray, Purge Value, Hose, Base, Mouth Piece.(Marked as Exhibit-A)
- 2) 01(One) Aafreen magai salsa having written tobacco causes painful death having components Tobacco, Molasses, Glycerin, Flavours. (Taken as sample for examination and Marked as Exhibit –B)
- 3) 01(one) Hookah Cap in which use flavour present (Marked as Exhibit-C)
- 4) 01 (one) Packet of Hookah Coil. (Marked as Exhibit-D)
- 5) One Small size Foil Paper.(Marked as Exhibit- E)

In this regard, I beg to report that on 01.05.2022 at evening received source information that at Anavrin Cafe, Hookah mixed with tobacco is being sold to the minors at PBR Market complex, Sevoke Road, under Bhaktinagar PS, Dist: Jalpaiguri. I shared the information with the IC PS and as per his direction; I along with force left to work out the information, noted vide GDE No. 43 Dated 01.05.2022 at 17.55 hrs. At the time of departure I took all the investigation kits. I accordingly along with available officer and force had been to the spot and conducted raid and could found that the above noted persons had been selling Hookah mixed with tobacco to their customers and including minor children's. Further, I demanded documents for the business but the staffs present there could not produce any documents. For this, a number of times meeting was conducted at PS level and clear instruction was given to all the Managers / Directors of Bar and Hookah Bars that no liquor or tobacco should be provided to minors. But the above noted arrested person disobeyed / violated the same. The above noted arrested persons had been selling noxious products to minors and also poisonous substance to the minors for their illegal gain. Accordingly, I seized all the above noted arrested under the same of the persons U/S 41 Crp.C informing their ground of arrest.

Under the above circumstance, I request you that a specific case may kindly be started under proper sections of law against the above noted persons and also the absconding Subham Agarwal owner of Anavrin Cafe and arranged for proper investigation of the case.
