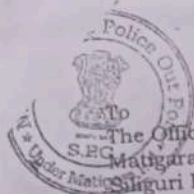

Sir,

In producing herewith three (03) arrested accused persons namely (1) Shibu Debnath @ Bau (25) S/O - Opu Debnath, of - Kawakhali, Bidhan Pally PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling, (2) Rabi Biswas @ Chhotu (24) S/O Subash Biswas, of Kawakhali, Selimghat, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling & (3) Sachin Barman @ Dipak (22) S/O - Digen Barman of Kawakhali, Selimghat, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron rod measuring 30 inch (approx) in length from the possession of Shibu Debnath which was kept on his right hand,
- (2) One Iron rod measuring 28 inch (approx) in length from the possession of Rabi Biswas which was kept on his right hand,
- (3) One sharp cutting weapon (Big size Daa) with wooden handle measuring measuring 32 inch (approx) in length from the possession of Sachin Barman which was kept on his right hand.
- (4) One packet chili powder from the possession of Shibu Debnath.

I, ASI Krishnendu Roy of NBMC OP under Matigara P.S., Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others to the effect that today on 02.05.2022 at 00.05 hrs, in course of night Van duty received a source information that 10/12 youths have assembled at a vacant ground at Hundred Feet near Desun Hospital, under Matigara PS with a view to commit dacoity at Thiknikata area. The fact was diarized in GDE vide NBMC OP GDE No-26 dated 02.05.2022. Subsequently, after sharing the information with my superiors and as per their direction, I along with C/1071 Sumit Sherpa, CV/158 Partha Sarkar and CV/920 Kamal Barman left for the place to work out the information.

At about 00.35 hrs after reaching at Hundred Feet near Desun Hospital, I met my source and as pointed by the source we started approaching towards the spot and cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence. But, seeing the police party approaching towards them they tried to flee away from the spot. On hot chase we managed to apprehend three accused persons along with seized articles from their possession as mentioned above who disclosed their name & address as (1) Shibu Debnath @ Bau (25) S/O - Opu Debnath, of - Kawakhali, Bidhan Pally PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling, (2) Rabi Biswas @ Chhotu (24) S/O Subash Biswas, of Kawakhali, Selimghat, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling & (3) Sachin Barman @ Dipak (22) S/O - Digen Barman of Kawakhali, Selimghat, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling



However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there and was planning to commit dacoity at Thiknikata area.

I thereafter, seized the above noted weapons under proper seizure in presence of witnesses and being acknowledged by the accused persons. The whole seizure was made in between 01.05 hrs. to 01.45 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons.

I accordingly brought the arrested accused persons along with seized article at Matigara Police Station for further investigation.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons namely (1) Shibu Debnath @ Bau (25) S/O - Opu Debnath, of - Kawakhali, Bidhan Pally PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling, (2) Rabi Biswas @ Chhotu (24) S/O Subash Biswas, of Kawakhali, Selimghat, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling & (3) Sachin Barman @ Dipak (22) S/O - Digen Barman of Kawakhali, Selimghat, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling and others and arrange for its investigation.
