like to inform you that yesterday ^{on 01/5/22} at about 4.30 P.M.
some persons at my locality namely ① Chandu Paul
S/o. Late Tarapada Paul, ② Tapash Paul, S/o. Chandu
Paul, both at their residence at Promod Nagar,
Road No. 05, P.S. Matigara, Dist. Darjeeling without
any reason they came in front of my house and
thereafter they started to use slang language
in respect of me and after listening the same
where I tried to protest them at that time they
became violent and started to assault me
by using some sharp cutting weapons like "DAU"
and "ROD" and for that reason I sustained
multiple injuries on my whole body and for
that reason I became senseless and with the
money of God some people came to the
spot and rescued me from their hands and
took me at Siliguri Sadar Hospital for
treatment.

It is important to mention here
that at time of the above-said incident
the above-noted persons intentionally disrobe
me and outraged my modesty in presence
of the local people and they also threatened
me with dire consequences and told me that
if I lodged any complaint against them
then they will kill me.
