The ground of arrest duly been communicated with

- One Iron made dragger recovered from the possession of accused Subha Modak. 1.
- One sharp cutting knife recovered from the possession of accused Dibjol Seikh.
- One iron made knife recovered from the possession of Promod Char.
- One iron made Bhojali recovered from the possession of accused Debasish Das. 4.
- One half burned candle found at # P.O.

I, SI Goutam Mallik of Matigara PS Siliguri Police Commissionerate would like to lodge this written complaint against the above noted 4 (four) arrested accused persons and 5/6 others unknown persons to the effect that today on 04.05.22 at about 00:45 hrs received a secret source information that a gang of miscreants assembled at near Teranga More, Patiram Jote under PS- Matigara, Dist.- Darjeeling with deadly weapons with a view to commit some heinous crime at the locality. Accordingly without waste any time I informed the matter to Officer-In-Charge, Matigara PS and diarized the fact in General Diary vide Matigara PS GDE No 150 dated 04.05.22 and as per order myself along with force left for the spot to verify the veracity of the information in hand. At about 01.15 hrs we reached near the spot and as indicated by the source we noticed that 09/10 persons sitting and gossiping there. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing away. Anyhow, after a hot chase we could able to apprehend the 04 (four) persons but 5/6 persons managed to fied away. On being asked they disclosed their name and identity as noted above. During interrogation they give different statement in different time and failed to give and satisfactory reply in regarding their presence in the middle of the night with deadly weapons. After further interrogation they disclosed that they assembled there with deadly weapons for committing dacoity after making full preparation in a house of Patiram Jote area under this PS Jurisdiction. Thereafter, all the apprehended persons were searched and the above noted articles recovered from their possession. Accordingly, I seized the same under proper seizure list and arrested them under proper memo of arrest and observing all the formalities of arrest. I like to note that due to late night I could not found any independent witness to be present at the time of search and seizure. The search and seizure made in between 02.25 hrs to 03.15 hrs.

Under the above noted fact and circumstances, I pray before you that a specific case under proper section of law may kindly be started against the above noted 04 (four) arrested accused persons namely (i) Subha Modak (23 yrs) S/O Ratan Moda of Budhya Mandir Road, Iskon Mandir, PS- Bhakti Nagar, Dist. Darjeeling (ii) Dibjol Selkh (19 yrs) S/O Badsa Selkh of Jhupri Busty, Paribahan Nagar, PS- Matigara, Dist.- Darjeeling (III) Promod Char (32 yrs) S/O late Dilip Char of Pati Colony, Upper Bagdorga, PS- Bagdogra, Dist.- Darjeeling and (iv) Debasish Das (24 yrs) S/O late Debu Das of Paribahan Nagar, PS- Matigara, Dist.- Darjeeling and 5/6 others unknown persons and arrange for its investigation.
