In producing herewith D4 (Four) arrested accused persons named (1) Arun Kr. Chowdhury (38) S/O Lt. Lt. Ram Sagar Chowdhury of Ashrampara Opposite Akash Nursing Home, Ward No-14, PS-Siliguri, Dist-Darjeeling (2) Raja Sariswal (36) S/O Sukhraj Sariswal of Sevoke road T.B Hospital Quater, Ward No-44, PS Bhaktinagar, Jalpaiguri A/P- Heiderpara Near Sima Bhawan , PS- Bhaktinagar, Dist- Jalpaiguri (3) Sourav Dey (39) S/O Lt Basu Dey of Bimal Singha Sarani, Hakimpura, Ward No-14, PS-Siliguri, Dist- Darjeeling and (4) Md. Kalam (26) S/O Md. Islam of Matangini Colony-2, Tikia Para, Ward No 28, PS- Siliguri Dist- Darjeeling along with seized articles (i) one knife measuring 10" including wooden handle wrapped from the possession of Arun Kr. Chowdhury (38) S/O Lt. Lt. Ram Sagar Chowdhury which was kept concealed on the back side waist (ii) one Hasua (sharp cutting weapon) measuring approx 16" including its wooden handle recovered from the possession of Raja Sariswal (36) S/O Sukhraj Sariswal which he was holding on his hand (iii) One iron rod measuring approx 26" pointed one end recovered from the possession of Sourav Dey (39) S/O Lt Basu Dey which was holding on his hand (iv) One iron rod measuring approx 36" pointed one end recovered from the possession of Md. Kalam (26) S/O Md. Islam which was holding on his hand under proper seizure list.

I, ASI Ashim Das of Panitanki TOP under Siliguri PS/ SPC do hereby lodge this written complaint against the above noted arrested persons to the effect that today on 30.04.22 at 23:45 hrs I received secret source information that 11/12 persons have been assembled at Mahananda river bed, behind Surya Sen Park to commit dacoity at the locality. Immediately informed the tip of information to O/C Panitanki TOP and as per his kind direction I diarized the fact in GD book vide Panitanki TOP GDE No-647 dated 30/04/22 and myself along with ASI Surojit Mallick, ASI Biswajit Saha, ASI Gopesh Ch Barman, C/984 Subhashish Das, C/702 Latifur Rahaman, CV-377 Dinesh Roy left for Mahananda river bed, behind Surya Sen Park to verify the veracity of the information. This refers Panitanki TOP GDE No-648 dated 30/04/22 and MCC No-531/22 dated 30/04/22. At about 00:05 hrs I along with Police party arrived at the spot i.e Mahananda river bed, behind Surya Sen Park and after keeping our vehicle at a distant place we proceeded towards Mahananda river bed on foot and being indicated by the source found from the considerable distance that a gang of 11/12 persons were assembled at Mahananda river bed, behind Surya Sen Park and they were whispering in very low voice. Accordingly, we cordoned the place properly and approach towards them. But seeing the presence of police party, they scattered in multi direction and started fleeing away but after a hot chase we manage to apprehended 04 (Four) persons and others were fled away from the spot. On interrogation, the apprehended persons disclosed their name & address as noted above, and started giving incoherent statement regarding their presence/gathering in the same place also. On further grilling they stated that, they along with 7/8 persons were assembled there in preparation to commit dacoity. Accordingly, I managed to call two independent witnesses on the spot and on being search in presence of the independent witnesses from the apprehended persons recovered (i) one knife measuring 10" including wooden handle wrapped from the possession of Arun Kr. Chowdhury (38) S/O Lt. Lt. Ram Sagar Chowdhury which was kept concealed on the back side waist (ii) one Hasua (sharp cutting weapon) measuring approx 16" including its wooden handle recovered from the possession of Raja Sariswal (36) S/O Sukhraj Sariswal which he was holding on his hand (iii) One iron rod measuring approx 26" pointed one end recovered from the possession of Sourav Dey (39) S/O Lt Basu Dey which was holding on his hand (iv) One iron rod measuring approx 36" pointed one end recovered from the possession of Md. Kalam (26) S/O Md. Islam which was holding on his hand. Accordingly, I seized the above noted recovered articles as per seizure list in presence of witnesses and duly signed by them in between 00:35 hrs to 01:15 hrs and I arrested them U/S 41 Cr.P.C. after explaining the charges against them.

Under the above fact and circumstances I pray that a specific case may kindly be started against (1) Arun Kr Chowdhury (38) S/O Lt. Lt. Ram Sagar Chowdhury (2) Raja Sariswal (36) S/O Sukhraj Sariswal (3) Sourav Dey (39) S/O Lt Basu Dey (4) Md. Kalam (26) S/O Md. Islam and others under proper Section of law.
